Technical Information

1. Dates

Volleyball competition for the 3rd Asian Youth Games 2025 will be held from 19-29 October 2025

2. Venues

Volleyball competition will be held in Bahrain, Riffa at Isa Sport City (Hall C & B).

3. Events

The volleyball competition will consist of two (2) events including the Men's Team and Women's Team.

4. Competition Format

4.1. Preliminary Round:

In men's and women's competition during the Preliminary Round (phase 1), four pools (A, B, C and D) will be formed by drawing of lots. The format is single round robin. Two highest ranked teams of each pool will proceed to Play-Offs (phase 2), in which the matches will be played in a single round robin to decide the ranking of each Play-Off group. The results between two teams in the same group in the Preliminary Round will be applied to Play-Offs. The 3rd ranked team of each pool will play Single Elimination for 9th – 12th ranked teams

SF 9th – 12th : 3A – 3C, 3B – 3D

Finals 9th – 10th : W (3A – 3C) – W (3B – 3D)

11th – 12th : L (3A – 3C) – L (3B – 3D)

4.2. Quarterfinals

1st – 8th: Eight teams of Pool E and Pool F will proceed to Quarterfinals after Playoff. They will play Single Elimination as follows:

1E – 4F, 1F – 4E, 2E – 3F, 2F – 3E

4.3. Semifinals

1st – 4th and 5th – 8th: Four winners of the quarterfinals will then advance to the semifinals 1st – 4th while the four losers will compete for the 5th to 8th place as follows:

1st – 4th: W (1E – 4F) – W (2F – 3E)

W (1F – 4E) – W (2E – 3F)

5th – 8th: L (1E – 4F) – L (2F – 3E)

L (1F – 4E) – L (2E – 3F)

4.4. Finals

Two winners of the semifinals will play the gold medal match to determine the gold and silver medals. Two losers of the semifinals will get the bronze medal. Two winners of semifinals will play the get 5th and 6th ranked and loser of the semifinals of 5th – 8th ranked teams will have a match to determine 7th and 8th ranked.

From 16 or 17 October 2025 until 30 October (07:00 to 20:00 hours)

6. Sport Entries

6.1. Eligibility

- Only OCA Member NOCs are entitled to send athletes to participate in the Volleyball competitions of the 3rd Asian Youth Games.
- Only athletes who comply with the OCA Constitution and Rules and its Bye-law are entitled to participate in the Volleyball competition.

6.2. Entry Timeline

- Entry by Sport: Deadline: 24:00 25 March 2025 (Manama Time, GMT +3)
- Entry by Number: from 10:00 30 June 2025 to 23:59 21 July 2025 (Bahrain Time, UTC +3)
- Entry by Name: from 10:00 1 August 2025 to 23:59 to 31 August 2025 (Bahrain Time, UTC +3)

6.3. Entry Policies

- Team events: Each NOC may enter only one (1) men's team and one (1) women's team.
- Total: Each NOC may enter a maximum of twelve (12) men and twelve (12) women Athletes
- The total of participating teams is not more than 12 men teams, and 12 women teams (NOC) will be qualified for the 3rd Asian Youth Games according to the following principle.

6.4. Age Limitation

Athlete participating in the Volleyball competition must be between 15 and 18 years of age as of December 31, 2025 born in 2007, 2008, 2009, and 2010. Must be born on or after 1 January 2007 and before or on 31 December 2010.

7. Arrival and Departure

Teams arrival is fixed two (2) days before the competition and depart one (1) day after it ends.

8. Technical Meeting

The Technical Meeting place and time will be confirmed.

9. TECHNICAL OFFICIALS

AVC will appoint the members of the Control Committee, including:

- 1 AVC Technical Delegate
- 1 Referee Delegate
- 4 Technical Sub Committee
- 3 Referee Sub Committee
- 2 Medical Delegate
- 2 IT Delegates
- 4 Video Challenge Supervisors

8.1 Referee

Each participating team should bring one (1) valid international referee. Teams participating in both men's competition and women's competition should bring two International Referees. The insufficient amount of international referees shall be mainly supplemented by the host country.

※ AF/IF has the right to appoint the Technical Delegate and ITOs in coordination and approval of OCA. In case of violation of the IF/AF Rules and Games Rules and Regulations by any participant, the OCA has the right to revoke the AD Card and propose change of the person to the concerned party.

10. Competition Rules:

- The Volleyball competition of the 2025 Asian Indoor will be held in accordance with the International Volleyball Federation (FIVB) Official Volleyball Rules and Regulations Edition 2025 -2028
- (https://www.fivb.com/en/volleyball/thegame_glossary/officialrulesofthegames), in force during the Games time. In case of any disagreement in the language interpretation of the rules and regulations, the English version shall prevail. Any unforeseen cases not covered by the regulations and rules shall be resolved as follows:
 - General issues : Resolved in accordance with OCA Constitution and Rules
 - Technical issues : Resolved in accordance with the (FIVB) Official Volleyball Rules and the Asian Volleyball Confederation (AVC) Regulations

Video Challenge System: Video Challenge System will be used during the Volleyball Indoor competition from the Preliminary Round up to the Finals. The VC System rules will be discussed during the General Technical Meeting.

11. General Rules and Regulations

11.1 Rules

11.1.1 Eligibility Code (OCA 52)

To be eligible for participation in the OCA Games, a competitor must:

- Observe and abide by the Rules of the IOC/OCA as per the Olympic Charter;
- Respect the spirit of fair play and non-violence and abide by the rules on the sports field;
- Comply with all aspects of WADA and OCA Anti-Doping Rules Code and refrain from using substances and drugs prohibited by the said organisations;
- The Member must ensure that any competitor in the OCA Games must be a national of the country of the NOC, which is entering him;
- Disputes relating to the determination of the country which a competitor may represent in the OCA Games shall be resolved by the EB, unless the eligibility code already set out in the Constitution has been fulfilled and is not in dispute.

11.1.2 Nationality of Competitor (OCA By-Law 52)

- All cases of infringement of IOC Rule 41, 42 and its Bye-laws and of the eligibility code of IFs shall be communicated by the concerned Member to the OCA, to be considered by the EB whose decision will be final;
- A competitor who is a national of two (2) or more countries at the same time may represent either one (1) of them, as he may elect. However, after having represented one country in the Olympic, Asian continental regional or world championships recognised by the relevant IF, the competitor may not represent another country unless he or she meets the conditions set forth in sub section 4 below that apply to the persons who has changed his nationality or acquired a new nationality;
- A competitor who has represented one country in the Olympic Games, OCA Games, continental, regional, and world championships recognised by the relevant IF, and who has changed his nationality or acquired a new nationality, shall not participate in the OCA Games to represent his new country until three years after such change or acquisition;
- If a State, Country or a colony acquires independence, a country becomes incorporated within another country by a change of border or transfer of sovereignty or if a new NOC is recognised by the OCA, a competitor may continue to represent the country to which he belongs or belonged. However, he may, if preferred, choose to represent his country or be entered in the OCA Games by his new NOC if one exists. This option can only be made once and is irreversible;



- e) In all cases not expressly addressed in these Bye-Laws, in particular those cases where a competitor would be in a position to represent a country other than that of which he is a national, or to have choice as to the country which he intends to represent, the EB makes all decisions. Decisions can be of a general The OCA Games 80 SEP 2017 or individual nature and issue specific requirements relating to nationality, citizenship, domicile or residence of the competitors, including the duration of any waiting period;
- f) Except as permitted by the EB, no competitor, coach or official who participates in the OCA Games may allow his person, name and picture or sports performances to be used for advertising purposes during the OCA Games.

11.1.3 Number of Entries (OCA 58)

- a) For a sport to be included in the OCA Games Programme a minimum of six (6) NOCs should enter their athletes by number and a minimum of four (4) should be physically present before the start of the competition;
- b) The maximum number of entries from each country in each sport or event is established by the Council in consultation with the Member hosting the Games and in accordance with the FIVB technical rules;
- c) However, the following numbers cannot be exceeded:
 - For individual events, two competitors from each Member;
 - For team events, one team per Member, the Number of competitors and reserves not to exceed the number allowed by the FIVB concerned;
 - For events where individual and team competitions are conducted simultaneously, and the team event is decided by the aggregate score/time of each individual member of the team, the athlete (if maximum two) participating in the individual event must be designated as such in the Entry form and only the athlete concerned will be competing in the individual event. This restriction overrides any regulations of the FIVB concerned.

11.1.5 Technical Official and Jury of Appeal (OCA 59)

The AGOC must not receive or otherwise give official recognition to any foreign political delegation or leaders of any other mission whatsoever, without the prior written approval of the OCA. However, nobody can be discriminated against if he or she is a duly appointed official of the NOC's sports delegation.

11.1.6 Court of Appeal (OCA 79)

- a) The OCA EB on behalf of the OCA is the final Court of Appeal, which will decide all disputes of a non-technical nature concerning the OCA Games. Teams/Member NOC's, if necessary, may submit disputes to the Court of Appeal. In addition, the Court of Appeal may intervene in all disputes of a nontechnical nature outside the jurisdiction of the Juries of Appeal set up for each sport in the Programme;
- b) The Court of Arbitration for Sport (CAS) in association with the OCA will set up a small Ad Hoc working group from CAS that will be present and working alongside the OCA in the Asian Games period only, on the same lines as done during the Olympic Games. The participating athletes can



address any issues that they may have directly with CAS, during the OCA Games.

11.1.7 Claims of Protest (OCA 80)

- a) Claims made to the Judges on grounds concerning matters of fact are decided by them without appeal;
- b) Appeals against other decisions of the Judges or with regard to any other matters must be addressed to the President of the Technical Jury of Appeal for the sport concerned by a representative of the team making the appeal;
- c) Exceptional circumstances apart, a claim must be made within two hours of the decision giving rise to it. The Jury, after an investigation, shall give a decision and this decision shall be irrevocable, except in the case of disqualification of a team or of a competitor for infraction of the Rules and Regulations of the OCA. In these case it shall be decided by the Court of Appeal;
- d) All claims and appeals must be made in writing.

11.1.8 Penalties in Case of Fraud (OCA 81)

A competitor proved to have transgressed by fraud the Rules of the OCA shall be disqualified and lose any position he or she may have gained. If this competitor's team is proved to have been party to the fraud, his/her team shall be disqualified in the sport involved.

12. Classification of Teams and Teams' Ranking System

- In order to establish the ranking of teams after the round-robin competition, the following criteria shall be implemented for all competition:
 - By the number of victories (matches won, matches lost) among teams of the same group. Teams that won more matches will get better ranking.
 - If there is an equal number of victories, then the following criteria shall be applied:
 - Number of points gained: If two (2) or more teams have the same number of victories (matches won, matches lost), they shall be classified in descending order by the points gained by each team per match as follows:

Match won 3-0; 3-1	3 points
Match won 3-2	2 points
Match lost 2-3	1 point
Match lost 0-3; 1-3	0 point
Match forfeited	0 point (25-0, 25-0, 25-0)

- If the teams are still tied after the number of victories and points gained, then the following criteria shall be applied
- Set quotient: If two (2) or more teams are tied on the number of points gained, they will be classified in descending order by the quotient resulting from the division of the number of all sets won by the number of all set loss.
- Point quotient: If there is still a tie based on the set quotient, the teams shall be classified in descending order by the quotient resulting from the division of all points scored by the total of points lost during all sets.
- If there is still a tie based on the point quotient, the priority will be given to the



team which won the last match between them.

- If the tie in point quotient is between three (3) or more teams, a new classification of these teams under the terms stated in paras 11.4.1 (i), (ii) and above shall be made taking into consideration only the matches involving the teams in question.

Official Draw: The Official Draw for the Volleyball competition shall be conducted by BAYG not later than one (1) month before the start of the Volleyball competition.

13. Protest and Appeals

All protests must be made by the Team Leader or Head Coach in writing to the AVC Control Committee, together with a protest fee of US\$ 300, within 30 minutes after the conclusion of the match. All appeals related to the technical sides will be the responsibilities of the International and Asian Federations.

14. Equipment and Clothing

14.1. Equipment and Clothing

Equipment used and clothing worn by athletes and other relevant participants in competition must comply with the rules and regulations of the OCA and FIVB in force. Neither Athletes nor technical officials can attach any form of commercial advertising to his or her competition uniform without prior agreement with OCA and BAYGOC.

14.2. Official Competition Ball

The Competition Official ball (Volleyball) will be “Mikasa”

15. Doping Control

Doping control procedures shall be conducted under the World Anti-Doping Code and the relevant anti-doping regulations issued by the OCA.

All participating athletes are subject to testing

16. Medical Code:

Doping is forbidden. The WADA (World Anti-Doping Agency)/IOC (International Olympic Committee) list shall apply and also, if the EB so decides, the list of the IF concerned. The Medical Committee shall also prepare a list of prohibited drugs; All OCA GAMES participants/competitors are liable to medical/doping control examinations which will be carried out in conformity with the Rules of the OCA Medical Committee and the OCA Anti-Doping Rules;

Any OCA GAMES participant/competitor refusing to submit a medical/Doping control examination, or who is found guilty of doping, shall be excluded from competition or from the present or future OCA GAMES. After the explanation of the team has been considered and the case discussed with the IF concerned, a team in which one or more members have been found guilty of doping may be excluded from the OCA GAMES in which it is participating. In sports where a team may no longer compete after a member has been excluded, the remaining competitors may compete in an individual capacity. An appropriate penalty including disqualification, withdrawal of medals, certificates, ranking and, accreditation, may be imposed by the EB on support personnel, referees, coaches, judges, managers and other officials associated with the team or any other person, other than the competitor, found involved in the doping offence;

A medal may be withdrawn or other penalties applied by order of the EB on a proposal of the OCA Medical Committee;

The above Regulations shall in no way affect further sanction by the IF and the NOC concerned, or any other action the EB may decide to take;



Competitors in sports restricted to women must comply with the prescribed gender test;

The Committee is responsible to ensure that these Rules are observed;

Members of this Committee may not act as team doctors;

The OCA Anti-Doping Rules will be followed for all OCA GAMES being held under the patronage of the OCA. These rules will be based on the WADA code and guidelines.

All Member NOCs of OCA, the IFs, AFs and the AGOC will abide by the OCA Anti-Doping Rules;

The OCA President shall also appoint an Anti-Doping Commission and a TUE Sub-Commission which will be responsible for the implementation of the Anti-Doping Rules during the course of the OCA GAMES. The Commission will work under the authority of the OCA Medical Committee Chairperson and will perform its duties and responsibilities in accordance with the directions from the EB;

The OCA President will also establish a Doping Control Department within the Structure of OCA. The Doping Control Department will be responsible for implementing the anti-doping programme which has been established by the EB and coordinate on a daily basis on the anti-doping programme with all the concerned agencies;

In addition to above all provisions of the OCA Anti-Doping Rules established by the OCA will be applicable.

17. Victory Ceremony

Medals to the winners of the OCA GAMES shall be presented by the OCA President. The President may delegate this privilege to other members of the OCA, accompanied by the President of the IF and/or AF concerned (or their deputy), if possible, immediately after the event and where the competition took place in the following manner;

The competitors who have been judged first, second and third shall take their places, in their sports uniforms, on a stand on the field facing the Tribune of Honour, with the winner slightly above the second who is on their right and the third who is on their left. The flag of the delegates of the winner shall be hoisted on the central flag-pole and those of the second and third on adjoining flagpoles on the right and on the left, as they face the arena. Meanwhile, the abbreviated National Anthem of the winner is played. The three competitors shall turn towards the flags;

The medal presentations shall be as per the following order:

- Bronze Medal – to the third and Fourth place winner.
- Silver Medal – to the second place winner.
- Gold Medal – to the first place winner.

No equipment or accessories may be taken by the athlete to the medal award ceremony or media interview areas, unless it is worn e.g. shoes and clothing which must be in accordance with the OCA commercial guidelines;

No kind of demonstration or commercial, political, religious or racial propaganda is permitted during the Victory Ceremony of the Games.

Any action of such kind will be subject to penalization by the Executive Board (EB) including disqualification, withdrawal of medals, certificates, accreditation, rankings and the like;

Any disrespect shown to the Games, Medals, Flags, Mascot or Certificates or any other material. by any athlete during the Victory Ceremony or during the Games will be subject to penalization by the EB, including but not limited to disqualification, withdrawal of medals, certificates, accreditation, rankings as decided by the EB; Victory, medals and diploma certificates, shall be in strict compliance with the OCA Protocol Guidelines. The design and format of the medals and diplomas shall be submitted to the OCA for its approval;





No other official/delegate from the participating delegations, other than the medal winners will be allowed on or near the podium during the medal presentation.

18. Approval of the Technical Handbook

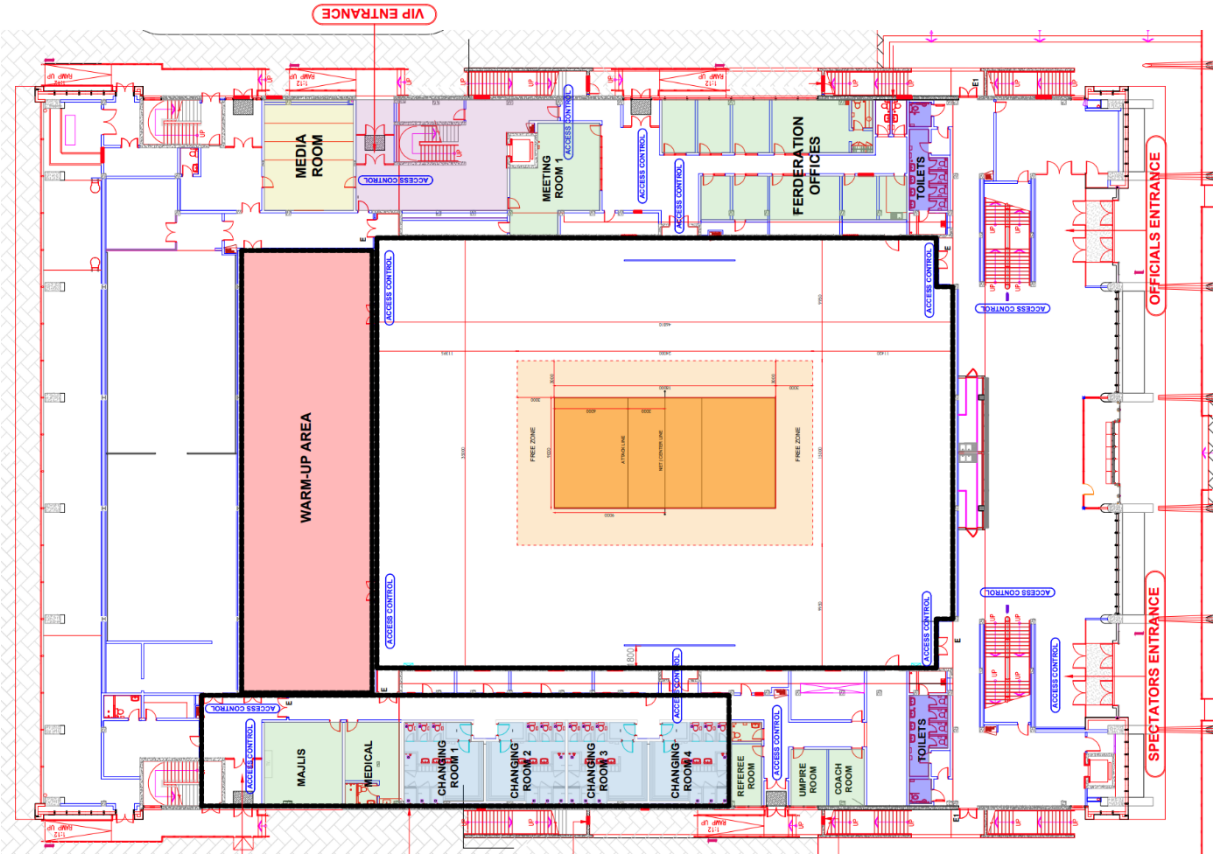
