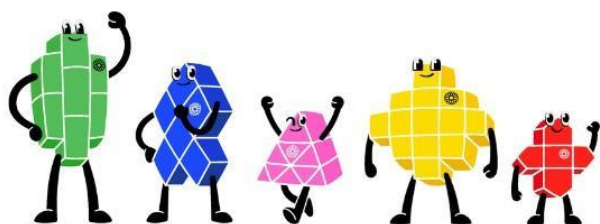

1. Each NOC may enter a maximum of sixteen (16) athletes, including eight (8) male and eight (8) female athletes for the Archery Competition.
  2. Each NOC may enter a maximum of four (4) male and four (4) female athletes for Recurve events
  3. Each NOC may enter a maximum of four (4) male and four (4) female athletes for Compound events
  4. Each NOC may enter a maximum of eight (8) team officials but not exceed the number of athletes.

## 5. Entries

### 5.1 Eligibility

- 5.1.1 Only SEAGF member NOCs are entitled to send athletes to participate in the Archery competition of the 33rd SEA Games Thailand 2025
- 5.1.2 Only athletes who comply with the World Archer Federation (WAF) Competition Rule (World Archery Rules Book 1, 2; update version 15 November 2024), the SEAGF Charter and Rules as well as Rule 40 and the By-law to Rule 40 of the Olympic Charter (Participation in the Games).
- 5.1.3 Only nationals of the country of the National Olympic Committee (NOC) shall be qualified to represent the NOC in the Games. All disputes relating to the determination of the country, which an athlete may represent in the SEA Games shall be resolved in accordance with the SEAGF Charter and Rules as well as Rule 41 and By-law to Rule 41 of the Olympic Charter (Nationality of competitors).
- 5.1.4 For eligibility matters, in the event of any conflict or inconsistency between the South East Asian Games Federation (SEAGF) Charter, THASOC and WAF, the latter shall prevail.
- 5.1.5 The Parent National Federation / Associations who are the affiliates of the SEAAF must be in good standing of their annual fees. The defaulted members are not eligible to participate in the Events.

### 5.2 Entry Policies

- 5.2.1 Each NOC may enter a maximum of sixteen (16) athletes, including eight (8) male and eight (8) female athletes for the Archery Competition.
- 5.2.2 Each NOC may enter a maximum of four (4) male and four (4) female athletes **for Recurve events**
- 5.2.3 Each NOC may enter a maximum of four (4) male and four (4) female athletes **for Compound events**
- 5.2.3 Each NOC may enter a maximum of eight (8) team officials but not exceed the number of athletes.

5.2.4 The total number of Officials must not exceed the number of athletes. One (1) of the Officials chosen shall be available for appointment as one (1) of the Judges.

\*\*\* NOCs that withdraw their athletes after the submission of the final entries by name, will be faced with disciplinary action by the SEAGF Charter and Rules.

## 8. General Rules and Regulations

### 8.1 Rules

#### 8.1.1 Eligibility Code (SEAGF 30)

To be eligible for participation in the SEA Games, a competitor must comply with the Federation's rules, regulations and by-laws, including this Charter and Rules, in particular in relation to eligibility and nationality, as well as the related provisions in the Olympic Charter, and the rules, regulations and by-laws for participation in the Olympic Games."

#### 8.1.2 Nationality of Competitor (SEAGF 31)

Only nationals of the country of the NOC who are holding current valid national passports of the country of that Member-NOC shall be qualified and eligible to represent the Member-NOC in the SEA Games. All disputes relating to the determination of the country which a competitor may represent in the SEA Games shall be decided by the Arbitration Panel established under this Charter and Rules, in accordance with the Federation's rules, regulations and by-laws, including this Charter and Rules, relating to eligibility and nationality."

#### 8.1.3 Number of Entries (SEAGF 34.3, 37)

- a) A minimum of four (4) NOCs must register to participate by the respective closing date of both the Entry by Number and the Entry by Name registration in a sport or discipline or team event and in the case of an individual event, a minimum of three (3) NOCs must register to participate by the closing date of both the Entry by Number and Entry by Name registration, for it to be included in the SEA Games programme. For the avoidance of doubt:
  - A doubles event shall be considered an individual event.
  - There shall be no waiver of this Rule on minimum entry."
- b) The maximum number of entries from each nation in each event is fixed by the Federation in consultation with the Host NOC. However, the following numbers cannot be exceeded:
  - For individual events, including singles and doubles events, there shall only be two (2) entries from each NOC (without reserves) EXCEPT for the sports with weight category, such as all martial arts and combat sports, Body-building, Weightlifting, etc., where there shall only be one (1) entry per weight category or per event from each NOC; and for the sport of Sailing, where there shall only be one (1) entry per event from each NOC.
  - For team events, there shall be one (1) team per NOC, and the number

of reserves shall not exceed the number of players allowed by the International Federation.

- For all events where individual competitions are conducted, the competitors for any one (1) NOC cannot win more than two (2) medals in the respective individual events.
- No Federation Member-NOC, including the Host NOC or the Organizing Committee of any SEA Games, is allowed to limit the participation of any other Federation Member-NOC or any athlete from participating in any sport, discipline or event solely on the ground or for any reason of limitation of participation.”

#### **8.1.7 Technical Officials and Jury of Appeal (SEAGF 41)**

- a) The necessary technical officials, referees, judges, umpires, timekeepers, inspectors and other technical officials (collectively “International Technical Officials” or ITOs”) and a Jury of Appeal for each sport in such number as shall be determined by the Host NOC or the Organizing Committee, shall be appointed by the Host NOC or Organizing Committee in consultation with the appropriate IF/AF and in cooperation with the respective National Federation of the Host NOC or local sport official/representative. All such ITOs and Jury of Appeal officials approved and appointed by the Host NOC or Organizing Committee shall be referred collectively as “IF/AF International Technical Officials” or IF/AF ITOs” and “Jury of Appeal” accordingly.
- b) The Organizing Committee shall pay for the air or international travel (based on best economy fare to the host city), accommodation (equivalent to a hotel of at least a 3-star internationally accepted rating, based on twin-share basis except for single rooms for Technical Delegates, Chief Umpires and Chief Scorer), meals, official local transport expenses and a per diem only of the IF/AF ITOs and Jury of Appeal officials at the established rates of the Organizing Committee starting from within than two (2) days before the start of the first event of the sport or discipline concerned until one (1) day after the end of the competition of the last event of that sport or discipline.
- c) In approving and appointments of ITOs and Jury of Appeal members, all IF and or AF concerned must give priority, first to the appointment of

- qualified ITOs and Jury of Appeal members who reside within the South East Asian (SEA) region, and second, to those who reside within the Asian continent, before appointing any ITOs or Jury of Appeal members from outside the SEA region or Asia continent.
- d) No official who has participated in a decision may serve in the Jury of Appeal that reviews it. The findings of the Jury of Appeal shall be communicated as soon as possible to the Federation Office, Host NOC, Organizing Committee and Executive Committee.
  - e) Technical officials and members of the Jury of Appeal may not live in the Games Villages, but the Organizing Committee shall ensure and bear the cost of their accommodation, including board and local transport facilities at such established rates of the Organizing Committee.
  - f) The Jury of Appeal's decision(s) on all technical questions concerning its respective sport or of disciplinary nature is/are final. Such decision shall, however, be without prejudice to any further penalty and or sanction, which may be imposed by the Executive Committee.
  - g) The Jury of Appeal shall be composed of a Chairperson (who shall be the Technical Delegate) and not more than two (2) other representatives as Jury of Appeal members, who shall be appointed by the IF/AF from amongst the IF/AF ITOS and or IF/AF representative(s) present at the Games.
  - h) In the event of a dispute or protest relating to technical questions concerning its respective sport, discipline and or event, or competition or any matter that is disciplinary in nature, that is referred to a relevant Jury of Appeal, representatives of countries in the Jury of Appeal whose countries are involved in the dispute or protest must NOT participate in the deliberations and or decision making and cannot vote in the resolution of the dispute or protest.
  - i) Any NOC dissatisfied with any decision of any Jury of Appeal (except decisions concerning matters of fact and judgment calls where no appeal is allowed) may refer his/her appeal to the Panel of Arbitrators

#### **8.1.8 Arbitration Panel (SEAGF 42)**

The Arbitration Panel shall deliberate and decide finally on all questions concerning the SEA Games or s, protests or appeals (including on any violation of anti-doping code, rules or regulations) from any sport, discipline or event or any disputes arising from or related to the SEA Games. NOCs or the Organizing Committee may also submit question or any matter related to the SEA Games to the Arbitration Panel for determination. Further, the Arbitration Panel may intervene in and determine all questions of non-technical nature outside the jurisdiction of the Jury of Appeal set up for each sport, discipline or event in the



Games programme.

### **8.1.9 Penalty in case of Fraud (SEAGF 44)**

A competitor proved to have fraudulently transgressed or breached any provisions of the Charter, Rules, Regulations or By-laws of the Federation shall be disqualified and lose any position or medal he/she may have gained. If this competitor's NOC is proved to have been a party to the fraud, his/her country shall be disqualified in the sport concerned.

## **9. Competition Rules and Regulations and Training Policy**

### **9.1 Competition Rules**

The Archery Competition of the 33<sup>rd</sup> SEA Games Thailand 2025 will be held in accordance with the current World Archery Federation (WAF) Competition Rules and Regulations (World Archery Rules Book 1, 2: update version 15 November 2024; World Archery Rules Book 3: update version 15 November 2024), in force during the Games time.

Competition Rules and Regulations under the guidance of Technical Delegate (TD) appointed by Southeast Asian Archery Federation (SEAAF) as authorized by the WAF.

In case of any disagreement in language interpretation of the WAF, Rules and Regulations, the English version shall prevail. Any unforeseen cases not covered by the WAF Rules and Regulations shall be resolved as follows:

**9.1.1 General Issues:** To be resolved in accordance with the SEAGF Charter and Rules.

**9.1.2 Technical Issues:** To be resolved in accordance with WAF Rules and Regulations (World Archery Rules Book 1, 2: update version 15 November 2024; World Archery Rules Book 3: update version 15 November 2024) and WAF Norms.

### **9.2 Competitional Format**

All Archery events shall be played with the following competition format:

#### **9.2.1 Individual Recurve**

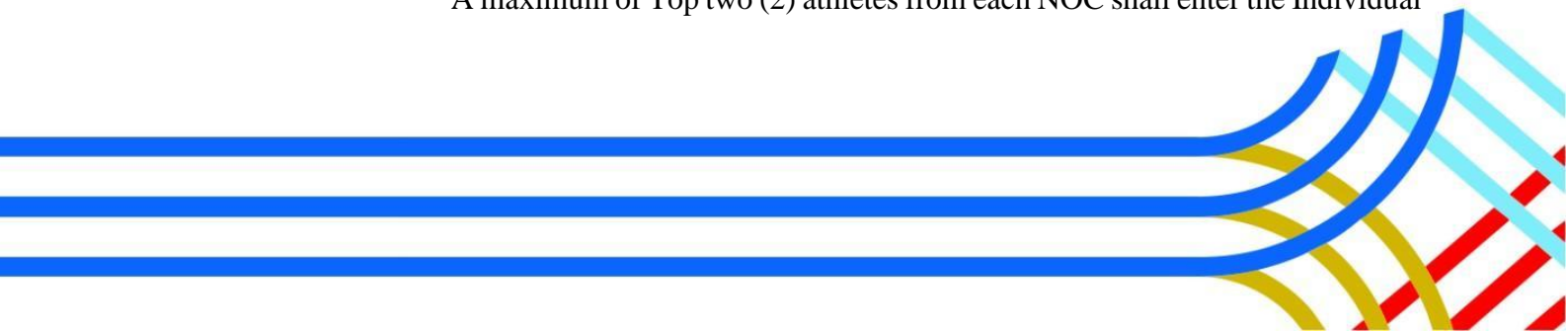
Individual Recurve events (Male and Female) shall consist of Qualification Round and Elimination Rounds. The competition formats are as follows:

##### **■ Qualification Round**

- a) Two (2) rounds of 36 arrows each
- b) Six (6) ends of six (6) arrows per round
- c) 180 sec per end

##### **■ Elimination Round**

A maximum of Top two (2) athletes from each NOC shall enter the Individual



#### Elimination Round.

- a) Top sixteen (16) archers match-play chart
- b) Maximum five (5) sets of three (3) arrows two (2) points for a win, one (1) point for a draw, and zero (0) points for a loss
- c) Timing: 90sec per set for non-alternate shooting, 20 seconds per arrow for alternate shooting
- d) The first archer to reach six (6) set points wins the contest and qualifies for the next round

All shots in Qualification Round and Elimination Rounds are taken from a distance of 70 m with 122 cm target face, with a maximum of ten (10) points per arrow. The archer with the highest number of set points is the winner.

### 9.2.2 Individual Compound

Individual Compound events (Male and Female) shall consist of Qualification Round and Elimination Rounds. The competition formats are as follows:

#### ■ Qualification Round

- a) Two (2) rounds of 36 arrows each
- b) Six (6) ends of six (6) arrows per round
- c) 180 sec per end

#### ■ Elimination Round

A maximum of Top two (2) athletes from each NOC shall enter the Individual Elimination Round.

- a) Top sixteen (16) archers match-play chart
- b) Cumulative scoring
- c) Five (5) ends of three (3) arrows
- d) Timing: 90sec per end for non-alternate shooting, 20 seconds per arrow for alternate shooting

All shots in Qualification Round and Elimination Rounds are taken from a distance of 50m with 80cm, 6-ring target face, with a maximum of ten (10) points per arrow. The archer with the highest score is the winner.

### 9.2.3 Team Recurve

Team Recurve events (Male, Female and Mixed) shall be directed to Elimination Rounds. The competition formats are as follows:

#### ■ Men and Women event

- a) Top three (3) archers per team;
- b) Ranking based on total qualification scores;
- c) Maximum four (4) sets of twenty-four (24) arrows - two (2) points for



- a win, one (1) point for a draw, and zero (0) points for a loss;
- d) Each set consists of six (6) arrows at 180 sec per set and two (2) arrows per archer for non-alternate and alternate shooting;
- e) The first team to reach five (5) points wins the contest and qualifies for the next round.

■ **Mixed Team event**

- a) Top male and female archers from each NOC;
- b) Ranking based on total qualification scores;
- c) Maximum four (4) sets of sixteen (16) arrows two (2) points for a win, one (1) point for a draw, and zero (0) points for a loss;
- d) Each set consists of four (4) arrows at eighty (80) seconds per set and two (2) arrows per archer for non-alternate and alternate shooting;
- e) The first team to reach five (5) points wins the contest and qualifies for the next round.
- f) All shots are taken from a distance of 70m with 122cm target face, with a maximum of ten (10) points per arrow. The team with the highest number of set points is the winner.

#### 9.2.4 Team Compound

Team Compound events (Male, Female and Mixed) shall be directed to Elimination Rounds. The competition formats are as follows:

■ **Men and Women event**

- a) Top three (3) archers per NOC;
- b) Ranking based on total qualification scores;
- c) Cumulative scoring for twenty-four (24) arrows four (4) ends of six (6) arrows at 180 sec per end and two (2) arrows per archer for non-alternate and alternate shooting;
- d) The team with the highest cumulative score wins the contest and qualifies the next round.

■ **Mixed Team event**

- a) Top male and female archers from each NOC;
- b) Ranking based on total qualification scores;
- c) Cumulative scoring for sixteen (16) arrows -four (4) ends of four (4) arrows at 80 seconds per end and two (2) arrows per archer for non-alternate and alternate shooting;
- d) The team with the highest cumulative score wins the contest and qualifies for the next round.
- e) All shots are taken from a distance of 50m with 80cm, 6-ring target face, with a maximum of ten (10) points per arrow. The team with the highest cumulative score is the winner.

### 9.2.5 Official Draw

After the final entries have been received, the Official Draw for target numbers and order of shooting will be held according to WAF Rules.

Two (2) archers will be assigned to each target.

### World Archery Rules Book 3 version 2024 Nov 15

#### Tie-Break Procedures

##### ■ Qualification Round

- a) Greatest number of 10's (including inner 10's)
- b) Greatest number of X's (inner 10's)

If archers are still tied after applying the above, a coin toss will decide the ranking.

##### ■ Elimination Round

###### a) Individuals:

- A single arrow shoot-off for score in Outdoor;
- If the score is the same the arrow closest to the Centre of the target face shall Tie-breaks for both Individual and Team events will be conducted in the following manner:
- resolve the tie and if the distance is the same, successive single arrow shoot-offs, until the tie is resolved.
- If both athletes miss the scoring area of the target, both athletes will shoot an additional arrow.

###### b) Teams:

- A three-arrow (two-arrow for Mixed Team) shoot-off for score, a single arrow by each team member;
- If the score is tied, the team with the arrow closest to the center shall win;
- If still tied the second arrow (or third) closest to the center shall determine the winner. c. Until official information about shoot-offs is given, athletes shall remain on the competition field. An athlete/team who is not present when the official results are announced, shall forfeit the shoot-off.

## 9.3 Penalty Rules

### 9.3.1 Losing the score of arrows

- An athlete arriving after shooting has started shall forfeit the number of arrows already shot, unless the Chair of the Tournament Judge Commission is satisfied that the athlete was delayed by circumstances beyond his control (see Book 3, Article 15.2.1 ).
- In the event (during the qualification round) of an equipment failure,

verified by a Judge, or a medical issue, verified by medical personnel, extra time may be given to make the necessary repairs, change the damaged equipment or for medical personnel to determine the problem and decide whether or not the athlete is fit to continue competing unassisted. However the maximum time or number of ends for make-up arrows to be shot is 15 minutes (following regular order of shooting and timing), or two ends of six arrows outdoors and three ends of three arrows indoors, whichever happens first. The athlete shall make up the appropriate number of arrows at the earliest opportunity under the supervision of a Judge.

- At world ranking events or international multi sport events no extra time shall be allowed for equipment failure or the treatment of medical problems, but the athlete concerned may leave the shooting line to resolve the issue and return to shoot any remaining arrow(s) if the time limit permits. In the Team Event other member(s) of the team may shoot in the meantime. (see Bk 3 12.2.3)
- An arrow shot before the start signal or after the stop signal, or out of sequence in alternating shooting, shall be considered as being part of that end and shall cause the athlete to lose the highest scoring arrow of that end which shall be scored as a miss.
- An arrow shot on the competition field after the Director of Shooting has officially closed the practice session on the competition field (which is after the pulling of the practice arrows) or during the breaks between distances or rounds shall cause the athlete to lose the highest scoring arrow of the next scoring end.
- In the team event, if any of the athletes of a team shoots an arrow before or after the relevant signal to start or finish the time period, that arrow shall count as part of that end and shall cause the team to lose the highest scoring arrow of that end which shall be scored as a miss.
- If more than the required number of arrows should be found in the target butt or on the ground near the target butt, or in the shooting lanes, only the three lowest (or six lowest, as the case may be) in value shall be scored (see Book 3, Article-15.2.5).
- If a member of a team fails to shoot his two arrows in an end the number of un-shot arrows shall still form part of that end. An unshot arrow shall be recorded as a miss. If the total number of arrows, including all un-shot arrows in any one end exceeds six (or four) arrows, Book 3, Article 15.2.5. shall apply.
- If a member of the team shoots more than the required number of arrows



in alternating shooting before returning behind the 1m line, the team shall lose the highest scoring arrow of that end. Book 3 Article 15.2.5

- An arrow not hitting a scoring zone, or hitting a target face other than the athlete's own target face shall be considered as part of that end and scored as a miss (Book 3, Article 15.2.8, 14.2.6.6., 14.2.6.7.).
- When Two faces are used and more than one arrow is shot into the same scoring area both (or all) arrows count as part of that end but only the lowest value arrow shall score.
- For the Team Compound Match Round, if more than three arrows (two for Mixed Team) are shot into the same scoring area, only the three lowest (two lowest for Mixed Team) value arrows shall score. The other arrow, or arrows, in the same scoring area shall be scored as a miss, or as misses

### **9.3.2 Team Round Time Penalties**

- If a member of a team crosses the 1m line too soon the Judge shall raise the yellow card. This card indicates that the athlete shall have to return behind the 1m line to start over again or be replaced by another athlete with arrows to shoot who shall start from behind the 1m line.
- If the team does not obey the yellow card and the athlete shoots his arrow, the team shall lose the highest scoring arrow for that end.
- The same procedure applies if a team member removes an arrow from the quiver or, in a compound team match, hooks his release aid on the string before standing on the shooting line

**9.3.3** Return behind the waiting line in case of yellow card violation in the team event.

**9.3.4** If a member of a team crosses the 1.0m line too soon or if a team member removes an arrow from the quiver before standing on the shooting line, the judge shall raise the yellow card. This card indicates that the athlete shall have to return behind the 1.0m line to start over again or be replaced by another athlete with arrows to shoot, who shall start from behind the 1.0m line. If the team does not obey the yellow card and the athlete shoots his arrow, the team shall lose the highest scoring arrow for that end

## **9.4 Protests and Appeals**

According to World Archery Federation (WAF) Competition Rules and Regulations (World Archery Rules Book 1, 2: update version 15 November 2024; World Archery Rules Book 3: update version 15 November 2024).



**Article 3.13.3.1:**

*An intention to appeal when it might affect the progression of an athlete from one stage of the competition to the next, shall be expressed in writing and lodged with the chairperson of the Tournament Judge Commission within five minutes of the end of the relevant round or match, whichever applies. During the Finals of match play rounds, the notice of intent to file an appeal shall be given within five minutes of the end of the match, or prior to the start of the next match, whichever is first.*

**Article 3.13.8:**

*Jury decisions shall be minuted and reported to the appellant, the chairperson of the Tournament Judge Commission and the organisers before the beginning of the next stage of the competition or before the awarding of prizes.*

**Article 3.13.4:**

*Amount paid is reviewed and determined by the World Archery Executive Board on an annual basis.*

- In the event of an athlete not being satisfied with a ruling given by the Judges, he may, except as provided for in Article 17.1. above, appeal to the Jury of Appeal according to 3.13. Jury of Appeal in Book 2. Trophies or prizes which may be affected by a dispute shall not be awarded until the Jury ruling has been given.
- The decision by the Judge on the value of an arrow before the withdrawal from the target face is final.
- The decision made by a Judge in the team round event concerning the use of the yellow card to signal the violations described in Article 15.3. is final.
- The decision of the Jury is final it cannot be appealed.
- An Appeal form is attached to this document (see attached after this chapter, Appendix 1).
- In case of an Intent to Appeal or an actual Appeal, the times indicated on the Appeal form must be considered.
- Appeal forms should be given to the Chairman of the Tournament Judge Commission or to their deputy.
- A fee of US\$200 must be paid to the Chairman of the Tournament Judge Commission, for the Appeal to be valid.
- If the Appeal is upheld by the Jury of Appeal, the fee will be returned. In the case of the Appeal being rejected, the fee will not be returned.

## 9.5 Delays, Postponement or Cancellations

The Technical Delegate must consult the THASOC Secretariate if there is any delay, postponement or cancellation of any competition that affects the scheduled times for “live boardcast” or victory ceremonies.

## 9.6 Training Policy



Pre-Games training will be allocated to all NPCs three (3) days prior to the start of the competition for the sports (including familiarization, if necessary) and this does not include the day of the Opening Ceremony.

### 9.6.1 Training Session

- Training sessions are strictly by allocation; no change and addition of training requests are allowed. NOCs are required to notify the Sport Information Desk if NOCs do not intend to use the allocated training session.

Target Butts, Target stands, Target Face, Timers, DOS Control and PA Systems will be provided at the training venue.

## 10. Technical Officials and Jury of Appeal

The appointments of Technical Officials and Jury of Appeal members will be in accordance with Article 41 of the SEAGF Charter and Rules.

### 10.1 International Technical Officials (ITOs)

The Jury of Appeal shall consist of the following members:

- Mr. Hoong Mau Sui, Frankie (SGP) Chairman of Jury of Appeal



- Mr. Rosendo SOMBRIO (PHI) Jury of Appeal Member
- Mr. Kyaw OO (MYA) Jury of Appeal Member

THASOC will pay for the costs of international transportation based on an economy direct-route fare, local transport, accommodation, and per diem for these Technical Officials (ITOs).

## **10.2 National Technical Officials (NTOs)**

Thailand Archery will appoint such number of National Technical Officials (NTOs) as may be approved by THASOC to assist the International Technical Officials.

## **10.3 Jury of Appeal**

The Jury of Appeal shall be comprised of one (1) Chairman and two (2) members representative from each participating NOC. The Technical Delegate will act as its chairman. The decision of the Jury of Appeal shall be final.

## **10.4 Judge Commission**

A Judge Commission (JC) shall comprise members who are either World Archery Judges or Continental Judges (CJs), with no more than 50% of CJs. The Chairperson of the Judge Commission shall be a World Archery Judge. Participating NOCs shall bear the international transportation cost for its nominated Technical Official while THASOC will bear costs related to local transport, accommodation, and per diem.

# **11. Official Equipment and Competition Attire**

## **11.1 Sports Equipment**

All sports equipment used by athletes in competition must comply with the SEAGF Charter and Rules and WAF Rules and Regulations.

## **11.2 Competition Attire**

- All clothing worn by athletes in competition must comply with the SEAGF Charter and Rules and WAF Rules and Regulations.
- Equipment used or clothing worn by athletes and other participants at the 33rd SEA Games Archery competition must comply with the WAF Constitution and Technical Rules and with the By-Law to Rule 50 of the Olympic Charter.
- All archers shall wear clothing specified in WAF Rules (Dress Regulation, Book 3, Article 20) in competitions and official ceremonies.

# **12. Media Interview**

- 12.1 All athletes should pass through the Mixed Zone as directed by the Media Officer.
- 12.2 Athletes and/or coaches should attend press conference and interview requests for them.

# **13. Prizes and Commendations**

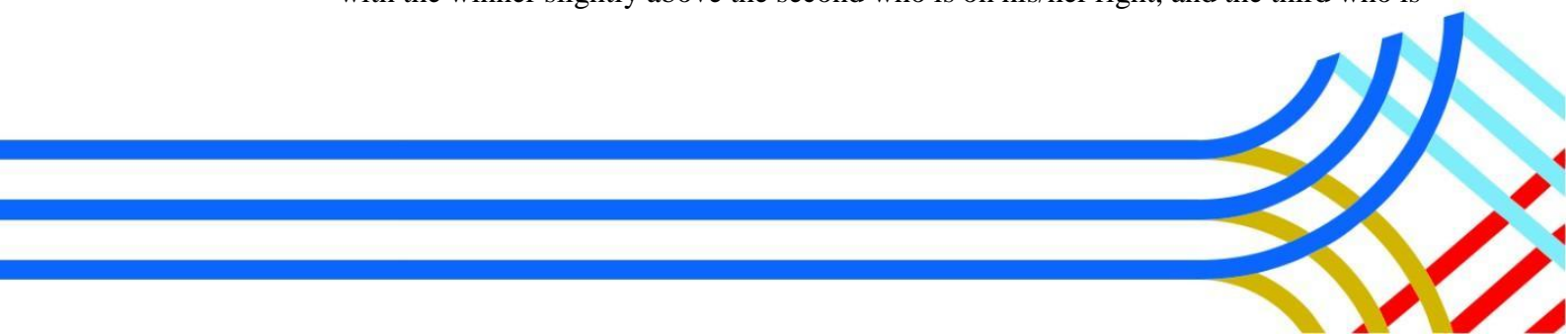


- Medals to the winners of the SEAGF Games shall be presented by the SEAGF President. The President may delegate this privilege to other members of the SEAGF, accompanied by the President of the IF and/or AF concerned (or their deputy), if possible, immediately after the event and where the competition took place in the following manner.
- The competitors who have been judged first, second and third shall take their places, in their sports uniforms, on a stand on the field facing the Tribune of Honour, with the winner slightly above the second who is on their right and the third who is on their left. The flag of the delegates of the winner shall be hoisted on the central flag-pole and those of the second and third on adjoining flagpoles on the right and on the left, as they face the arena. Meanwhile, the abbreviated National Anthem of the winner is played. The three winners/winning teams shall turn towards the flags.
- The medal presentations shall be as per the following order:
  - Gold Medal – to the first-place winner.
  - Silver Medal – to the second-place winner.
  - Bronze Medal – to the third-place winner.
- All medalists must wear their respective NOC official uniform.
- No equipment or accessories may be taken by the athlete to the medal award ceremony or media interview areas, unless it is worn, e.g., shoes and clothing which must be in accordance with the SEAGF commercial guidelines.
- No kind of demonstration or commercial, political, religious or racial propaganda is permitted during the Victory Ceremony of the Games. Any action of such kind will be subject to penalization by the Executive Board EB including disqualification, withdrawal of medals, certificates, accreditation, rankings and the like.
- Any disrespect shown to the Games, Medals, Flags, Mascot or Certificates or any other material. by any athlete during the Victory Ceremony or during the Games will be subject to penalization by the EB, including but not limited to disqualification, withdrawal of medals, certificates, accreditation, rankings as decided by the EB.
- Victory, medals and diploma certificates, shall be in strict compliance with the SEAGF Protocol Guidelines. The design and format of the medals and diplomas shall be submitted to the SEAGF for its approval.

#### 14. Victory Ceremonies

The medals may be presented by the board members of the Member-NOCs participating in the particular sport, discipline or event (with priority being given to those with medal winners) and or Guests of Honor of the Federation, and such victory ceremonies, if possible, shall take place immediately after the event at a place where the competition took place and in the following manner:

- The competitors who have been judged first, second and third shall take their places, in their sport attire or NOC designated attire, on a stand facing the Tribune of Honor, with the winner slightly above the second who is on his/her right, and the third who is





on his/her left.

- The flag of the country of the winner shall be hoisted on the central flagpole or screen and those of the second and third on adjoining flagpoles or screen on the right and left as they face the arena. Meanwhile, the National Anthem of the country of the winner is played and the competitors and spectators shall face the flags.

## 15. Medical Code (SEAGF 33)

- The Host NOC and Organizing Committee of the SEA Games will ensure the health of all athletes and other participants during the SEA Games.
- Anti-Doping Rule Violations as defined by the World Anti-Doping Agency (WADA) Code is forbidden.
- All competitors shall be subject, during the Games, to doping control initiated by the Federation at any time or place, carried out in conformity with the WADA Code and its respective International Standards, as elaborated in the SEA Games Anti-Doping Rules.
- Competitors in sports restricted to women must comply with the prescribed tests for disorders of sexual determination when so needed.
- Any competitor refusing to submit to doping control or who is found guilty of any Anti-Doping Rule violation shall be excluded from the SEA Games.
- The principles of exclusion for teams and individuals shall be in accordance with the WADA Code.
- A medal may be withdrawn by order of the Executive Committee or the Council on the recommendation of the Chairperson of the Anti-Doping Committee when an athlete is found guilty of a violation under the SEA Games Anti-Doping Rules and or the WADA Code.
- The Anti-Doping Committee shall manage and implement the doping test programme for the SEA Games to which it was appointed for in accordance with WADA requirements, and implement the SEA Games Anti-Doping Rules and WADA Code.
- The SEA Games Anti-Doping Rules and Regulations shall in no way affect further and or other sanctions by the relevant International Federation, WADA and or any other relevant national, regional, continental, international or world organizations or bodies.
- All competitors and officials are also subject to, and shall comply with the respective anti-gaming and manipulation, and harassment and abuse, and safeguarding rules, regulations, codes and guidelines of the respective Federation Member-NOC, IOC, OCA, SEAGF, the respective IF and or AF of the sport concerned.
  - a) Any competitor or team official refusing to submit thereto or found guilty of any violation or offence thereunder shall be excluded from the SEA GAMES.
  - b) A medal may be withdrawn by order of the Executive Committee or the Council on the recommendation of the Arbitration Panel when an athlete is found guilty of any violation or offence thereunder.”



## **16. Doping Control**

The 33<sup>rd</sup> SEA Games Thailand 2025 Organizing Committee, shall establish the SEAGF Anti-Doping Committee, which shall, under the guidance of the SEAGF and working with the SEAGF Office, be responsible for the Anti-Doping program for the 33<sup>rd</sup> SEA Games Thailand 2025. The Anti-Doping program will be run in accordance with the SEAGF Anti-Doping Rules and the WADA International Standard for Testing and Investigation. Sample analysis will be performed at a WADA-accredited laboratory or as otherwise approved by WADA. Both urine and blood tests will be conducted before and during the competition to ensure compliance.

Athletes requiring the use of a Prohibited Substance or Prohibited Method during the event must apply for a Therapeutic Use Exemption (TUE) through the SEAGF Anti-Doping Committee by the specified deadline (TBC). If an athlete has already been granted a TUE by their National Anti-Doping Organization or International Federation, the SEAGF Anti-Doping Committee will recognize it.

## **17. Approval of the Technical Handbook**

This Technical Handbook was approved by the the World Archery Asia (WAA) **on 26 March 2025**

Any further amendments to the Technical Handbook shall be circulated via e-mail to the NOCs.
