

Note:

- 1. Each NOC may enter a maximum of twenty-nine (29) including thirteen (13) male athletes and sixteen (16) female athletes for the Rowing Classic Competition.
- 3. Each NOC may enter a maximum of two (2) athletes including one (1) male and one (1) female athlete for the Rowing Beach Sprint event.
- 3. Each NOC may enter a maximum of one (1) boat per each competition event.
- 4. Each Athlete may complete in a maximum of two (2) event in the Rowing (Classic) and one (1) event in Rowing (Sprint) Competition
- 5. Each NOC may enter a maximum of one (1) athlete in single event.
- 6. Each NOC may enter a maximum of three (2) athletes (including two (2) athletes in competition and one (1) spare) in <u>Double/Pair event</u>.
- 7. Each NOC may enter a maximum of six (6) athletes (including four (4) athletes in competition and two (2) spare) in Quadruple/Four event.

#### **Event Group**

The competition events will be divided into Group A and Group B as follows: each event group will take place on the same day. Teams are strongly advised not to make double-up entries for athletes or crews or share equipment in the same group. Teams doing so make such entries entirely at their own risk and no changes to the race schedule will be made to accommodate double entries in the same group.

#### 5. Entries

#### 5.1 Eligibility

- 5.1.1 Only SEAGF member NOCs are entitled to send athletes to participate in the Rowing competition of the 33rd SEA Games Thailand 2025
- 5.1.2 Only nationals of the country of the National Olympic Committee (NOC) shall be qualified to represent the NOC in the Games. All disputes relating to the determination of the country, which an athlete may represent in the SEA Games shall be resolved in accordance with the SEAGF Charter and Rules as well as Rule 41 and By-law to Rule 41 of the Olympic Charter (Nationality of competitors).
- 5.1.3 A competitor who is a national of two (2) or more countries at the same time may represent either one (1) of them, as he may elect. However, after having represented one country in the Olympic, Asian continental and South East Asian continental regional or world championships recognized by the relevant IF, the competitor may not represent another country unless he or she meets the conditions set forth in sub section 4 below that apply to the persons who has changed his nationality or acquired a new nationality.
- 5.1.4 For eligibility matters, in the event of any conflict or inconsistency between the South East Asian Games Federation (SEAGF) Charter, THASOC and Asian Rowing Federation (ARF), the latter shall prevail.

#### 5.2 Entry Policies

- 5.2.1 Each NOC may enter a maximum of twenty-nine (29) for the Rowing Classic Competition as follow:
  - Thirteen (13) male athletes
  - Sixteen (16) female athletes.
- 5.2.2 Each NOC may enter a maximum of two (2) athletes including one (1) male and one (1) female athlete for the Rowing Beach Sprint event.
- 5.2.3 Each NOC may enter a maximum of one (1) boat per each competition event.
- 5.2.4 Each Athlete may complete in a maximum of two (2) event in the Rowing (Classic) and one (1) event in Rowing (Beach Sprint) Competition
- 5.2.5 Each NOC may enter a maximum of one (1) athlete in single event.
- 5.2.6 Each NOC may enter a maximum of three (2) athletes (including two (2) athletes in competition and one (1) spare) in <u>Double/Pair event</u>.
- 5.2.7 Each NOC may enter a maximum of six (6) athletes (including four (4) athletes in competition and two (2) spare) in <a href="Quadruple/Four event">Quadruple/Four event</a>.







\*\*\* NOCs that withdraw their athletes after the submission of the final entries by name, will be faced with disciplinary action by the SEAGF Charter and Rules.

#### 8. General Rules and Regulations

#### 8.1 Rules

#### 8.1.1 Eligibility Code (SEAGF 30)

To be eligible for participation in the SEA Games, a competitor must comply with the Federation's rules, regulations and by-laws, including this Charter and Rules, in particular in relation to eligibility and nationality, as well as the related provisions in the Olympic Charter, and the rules, regulations and by-laws for participation in the Olympic Games."

#### **8.1.2** Nationality of Competitor (SEAGF 31)

Only nationals of the country of the NOC who are holding current valid national passports of the county of that Member-NOC shall be qualified and eligible to represent the Member-NOC in the SEA Games. All disputes relating to the determination of the country which a competitor may represent in the SEA Games shall be decided by the Arbitration Panel established under this Charter and Rules, in accordance with the Federation's rules, regulations and by-laws, including this Charter and Rules, relating to eligibility and nationality."

#### **8.1.3** Number of Entries (SEAGF 34.3, 37)

- a) A minimum of four (4) NOCs must register to participate by the respective closing date of both the Entry by Number and the Entry by Name registration in a sport or discipline or team event and in the case of an individual event, a minimum of three (3) NOCs must register to participate by the closing date of both the Entry by Number and Entry by Name registration, for it to be included in the SEA Games programme. For the avoidance of doubt:
  - A doubles event shall be considered an individual event.
  - There shall be no waiver of this Rule on minimum entry."
- b) The maximum number of entries from each nation in each event is fixed by the Federation in consultation with the Host NOC. However, the following numbers cannot be exceeded:
  - For individual events, including singles and doubles events, there





shall only be two (2) entries from each NOC (without reserves) EXCEPT for the sports with weight category, such as all martial arts and combat sports, Body-building, Weightlifting, etc., where there shall only be one (1) entry per weight category or per event from each NOC; and for the sport of Sailing, where there shall only be one (1) entry per event from each NOC.

- For team events, there shall be one (1) team per NOC, and the number of reserves shall not exceed the number of players allowed by the International Federation.
- For all events where individual competitions are conducted, the competitors for any one (1) NOC cannot win more than two (2) medals in the respective individual events.
- No Federation Member-NOC, including the Host NOC or the Organizing Committee of any SEA Games, is allowed to limit the participation of any other Federation Member-NOC or any athlete from participating in any sport, discipline or event solely on the ground or for any reason of limitation of participation."

#### 8.1.7 Technical Officials and Jury of Appeal (SEAGF 41)

- a) The necessary technical officials, referees, judges, umpires, timekeepers, inspectors and other technical officials (collectively "International Technical Officials" or ITOs") and a Jury of Appeal for each sport in such number as shall be determined by the Host NOC or the Organizing Committee, shall be appointed by the Host NOC or Organizing Committee in consultation with the appropriate IF/AF and in cooperation with the respective National Federation of the Host NOC or local sport official/representative. All such ITOs and Jury of Appeal officials approved and appointed by the Host NOC or Organizing Committee shall be referred collectively as "IF/AF International Technical Officials" or IF/AF ITOs" and "Jury of Appeal" accordingly.
- b) The Organizing Committee shall pay for the air or international travel (based on best economy fare to the host city), accommodation (equivalent to a hotel of at least a 3-star internationally accepted rating, based on twin-share basis except for single rooms for Technical





Delegates, Chief Umpires and Chief Scorer), meals, official local transport expenses and a per diem only of the IF/AF ITOs and Jury of Appeal officials at the established rates of the Organizing Committee starting from within than two (2) days before the start of the first event of the sport or discipline concerned until one (1) day after the end of the competition of the last event of that sport or discipline.

- c) In approving and appointments of ITOs and Jury of Appeal members, all IF and or AF concerned must give priority, first to the appointment of qualified ITOs and Jury of Appeal members who reside within the South East Asian (SEA) region, and second, to those who reside within the Asian continent, before appointing any ITOs or Jury of Appeal members from outside the SEA region or Asia continent.
- d) No official who has participated in a decision may serve in the Jury of Appeal that reviews it. The findings of the Jury of Appeal shall be communicated as soon as possible to the Federation Office, Host NOC, Organizing Committee and Executive Committee.
- e) Technical officials and members of the Jury of Appeal may not live in the Games Villages, but the Organizing Committee shall ensure and bear the cost of their accommodation, including board and local transport facilities at such established rates of the Organizing Committee.
- f) The Jury of Appeal's decision(s) on all technical questions concerning its respective sport or of disciplinary nature is/are final. Such decision shall, however, be without prejudice to any further penalty and or sanction, which may be imposed by the Executive Committee.
- g) The Jury of Appeal shall be composed of a Chairperson (who shall be the Technical Delegate) and not more than two (2) other representatives as Jury of Appeal members, who shall be appointed by the IF/AF from amongst the IF/AF ITOS and or IF/AF representative(s) present at the Games.
- h) In the event of a dispute or protest relating to technical questions concerning its respective sport, discipline and or event, or competition or any matter that is disciplinary in nature, that is referred to a relevant Jury of Appeal, representatives of countries in the Jury of Appeal whose countries are involved in the dispute or protest must NOT participate in the deliberations and or decision making and cannot vote in the resolution of the dispute or protest.
- i) Any NOC dissatisfied with any decision of any Jury of Appeal (except decisions concerning matters of fact and judgment calls where no appeal is allowed) may refer his/her appeal to the Panel of Arbitrators





#### 8.1.8 Arbitration Panel (SEAGF 42)

The Arbitration Panel shall deliberate and decide finally on all questions concerning the SEA Games or s, protests or appeals (including on any violation of anti-doping code, rules or regulations) from any sport, discipline or event or any disputes arising from or related to the SEA Games. NOCs or the Organizing Committee may also submit question or any matter related to the SEA Games to the Arbitration Panel for determination. Further, the Arbitration Panel may intervene in and determine all questions of non-technical nature outside the jurisdiction of the Jury of Appeal set up for each sport, discipline or event in the Games programme.

#### 8.1.9 Penalty in case of Fraud (SEAGF 44)

A competitor proved to have fraudulently transgressed or breached any provisions of the Charter, Rules, Regulations or By-laws of the Federation shall be disqualified and lose any position or medal he/she may have gained. If this competitor's NOC is proved to have been a party to the fraud, his/her country shall be disqualified in the sport concerned.

#### 9. Competition Rules and Regulations

#### 9.1 Technical Officials

The Rowing and Canoeing Association of Thailand: RCAT is responsible for and has full control of the technical organization of the Rowing competition, in consultation with the International Technical Delegates (TD)

#### 9.2 Competition Rules

<u>The Rowing competition</u> of the 33rd SEA Games Thailand 2025 will be held in accordance with the latest World Rowing Rules Book (WR), in force during the Games time.

Competition Rules and Regulations under the guidance of Technical Delegate (TD) appointed by SEARF.

In case of any disagreement in language interpretation of the Competition Rules and Regulations, the English version shall prevail. Any unforeseen cases not covered by the rules and regulations shall be resolved as follows:

**9.1.1 General Issues:** To be resolved in accordance with the SEAGF Charter

and Rules.

**9.1.2 Technical Issues:** To be resolved in accordance with WR Rules and

Regulations and WR Norms.







#### 9.3 Competitional Format

#### 9.3.1 Rowing (Classic)

The racing course shall have six (6) lanes, measuring 2,000 meters in length and thirteen point five (13.5) meters in width.

#### 9.3.1.1 Progression System

Should the number of the crews taking part in an event exceed the number of lanes designated by the Organizing Committee, a progression system shall be used to determine the finalists. The progression systems shall be applied according to World Rowing Rules of Racing (WR) on the Progression system.

#### 9.3.1.2 Draw

The allocation of lanes for teams at the elimination heats or preliminary race will take place during the Team Manager's Meeting by Draw.

#### 9.3.1.3 Tie-Break Procedures

In a heat, if a dead heat occurs between crews, the crew which had the higher ranking in the immediately preceding round will progress to the next round. If all crews involved in the dead heat progresses anyway into the next round, there will be no re-row.

In a Repechage round, if a dead heat occurs between crews and if only one (1) of the crews progresses into the next round, it shall be the crew which had the highest ranking in the immediately preceding round. The immediately preceding round shall be the last previous round in which both/all of the dead heat crews competed. If the crews had the same result in that round, then the ranking of the next previous round shall be used for this purpose. If on this basis of the results of the crews concerned are identical, then there must be a re-row over the full course between the crews involved. If all crews involved in the dead heat progresses anyway into the next round, there will be no re-row.

In a final, if a dead heat occurs between crews, then they will be given equal placing in the final order and the next placing(s) shall be left vacant.

#### 9.3.2 Rowing (Beach Sprint)

The racing course shall have 2 lanes where the competition course is on the open sea. The course shall comprise (1) a land section (2) a water section (3) a land section which include a run on the beach of between approximately 10 meters and 50 meters to start and finish the race with an on-water distance of 250 meters approximately from the beach to the farthest turning buoy. The race will then comprise 10 meters and 50 meters run from the start line to the







water, 250 meters (buoys at approximately 85m+85m+80m) row out, a similar 250 meters row back and 10 meters and 50 meters run to the finish.

#### **9.3.2.1** Time trial

The crews shall race from the beach in a slalom around each of the three buoys in turn in the lane designated as the out-bound lane, turning 90 degrees at the outermost buoy, rowing directly to the outermost buoy of the designated in-bound lane and after rounding this buoy shall race directly in a straight line back to the designated point on the beach and run to the beach finish line. Crews must correctly round all buoys and not interfere with other crews (Annex A)

#### 9.3.2.2 Repechage, Quarter Final, Semi Finals and Finals:

The crews shall race "Slalom out/Straight back" When all crews are in their boats, they shall race from the beach in a slalom fashion around each of the three buoys in turn in their respective racing lanes, turning around the last buoy. After rounding the last buoy, they shall then race directly in a straight line back to the designated point on the beach. (Note: Crews not taking a straight line course back to the beach or arriving at the beach at other than the designated point shall not be penalized as long as they do not these Regulations.) Crews must ensure that they go around each of the three buoys in turn in the correct direction on the outward sector. (Annex B)

#### 9.3.2.3 Draw

The allocation of the time trail for all crew will take place during the Team Manager's Meeting by Draw.

#### 9.3.2.4 Tie Break Procedures

If there is a dead-heat in any round other than a final, there must be a re-row over the same course between the crews involved. The re-row must take place not later than 10 minutes after the finish of the race in which the dead-heat occurred. If the re-row results in a dead-heat the crews shall be required to re-row the race again not later than 15 minutes after the finish of the previous re-row. This process will continue until a decision is reached. If a dead-heat occurs in a final the crews concerned shall be given equal ranking and the next ranking shall be left vacant.

#### 9.3.2.5 Boat Handlers

There shall be up to two (2) boat handlers per boat. In adverse or rough water conditions the President of the Jury may allow or may require the number of boat handlers per boat to be increased. The





boat handlers for each crew should wear matched uniforms or bib and are clearly distinguishable from the crew.

#### 9.4 Crew Change

- Up to half of the number of rowers in a crew may replace. The changes must be communicated in writing to the President of Jury at least one (01) hour before the first Heat of the event. A crew which has already raced in the Heat of its event may not make changes in the crew, except in the case of a serious illness or injury by submission of the medical certificate.
- For a single sculler, in case of a serious illness or injury, the changes must be communicated in writing to the President of Jury at least one (1) hour before the first Heat of the event by submit a medical certificate and a crew which has already raced in the Heat of its event may not make changes.

#### 9.5 Equipment Control

#### **Rowing (Classic)**

Participating teams encourage to bring their own boats and oars.

#### **Rowing (Beach Sprint)**

All boats and other equipment must comply with WR Rules of Racing. All boats and other equipment will be provided by OC and official boat supplier, Swift Racing.

- All crews shall use the pool boats allocated to them for each race. Crews may not use their own boats.
- All boats will be set on a standard World Rowing rigging and this may not be
  - changed. Only the foot stretcher can be adjusted before each race.

**Oars:** Each team is highly recommended to bring their own oars and sculls as the blades of all oars/sculls must be painted on both sides in the colors of the respective Federations.

#### 9.6 Protests and Appeals

- Protest and appeal will be handled in accordance with World Rowing Rules Book (WR). All the protest related to technical issues will be solved by Board of the Jury. The Board of the Jury's decision is the final.
- Any written protest must be made and submitted by the Chef de Mission or Team Manager to the President of the Jury after the competition with the payment of a Protest Fee of 100 Euros per protest payable to THASOC. If conditions causing a potential protest are noted prior to the start of the event, a written protest must be lodged before the signal to start the event is given.







- All protests must be considered by the Board of the Jury concerned who must make a decision as soon as possible. Board of the Jury must state the reason(s) for their upholding/rejecting the protest.
- Any Chef de Mission or Team Manager dissatisfied with the decision of the Board of the Jury, may appeal to the Jury of Appeal by submitting the written appeal to the Jury of Appeal within sixty (60) minutes of receipt of the Board of the Jury's written decision. The appeal must be heard and decided by the Jury of Appeal within two (2) hours after receipt of the written appeal.
- Any NOC dissatisfied with any decision by the Jury of Appeal may make any appeal in accordance with the SEAGF Charter and Rules.
- The protest fee shall be refunded if the protest is upheld; it will be forfeited if the protest is rejected

#### 9.7 Delays, Postponement or Cancellations

The Technical Delegate must consult the THASOC Secretariate if there is any delay, postponement or cancellation of any competition that affects the scheduled times for "live boardcast" or victory ceremonies.

#### 9.8 Training Policies

Pre-Games training will be allocated to all NOCs two (2) days prior to the start of the competition of the sport to familiarize with the competition venue. Training sessions are strictly by allocation of Organizing Committee; and addition of training requests are allowed. If NOCs do not intend to use allocated training session, NOCs are required to notify the officer at Sport Information Desk.





#### 10. Technical Officials and Jury of Appeal

The appointment of the Technical Delegate, Technical Officials and Jury members will be in accordance with SEAGF Charter and Rules as well as Asian Rowing Federation (ARF) competition rules and regulation.

AF/IF has the right to appoint the Technical Delegate and International Technical Officials (ITOs) in coordination and approval of the SEAGF. In the event of any violation of the AF/IF Rules or Games Rules and Regulations by any participant, the SEAGF has the right to revoke his or her accreditation card and propose replacement of the participant concerned to the relevant party

#### 10.1 Technical Delegate (TD)

The Executive Committee of the Southeast Asian Rowing Federation (SEARF) shall appoint Technical Delegate for Rowing competition at 33rd SEA Games Thailand 2025.

#### 10.2 International Technical Officials (ITOs)

- The Juries will be appointed by the Southeast Asian Rowing Federation (SEARF) Committee.
- Each NOC shall nominate two (2) International Juries for Classic Rowing and one (1) International Juries for Beach Sprint Rowing to officiate the competition.
- In case of insufficiency of Juries, The Southeast Asian Rowing Federation (SEARF) Committee may appoint more Juries to work at the Games.

THASOC will cover the costs of the international and local transportation, accommodation and working periderm for International Technical Officials (ITOs).

#### 10.3 National Technical Officials (NTOs)

The Rowing and Canoeing Association of Thailand: RCAT will appoint a number of National Technical Officials (NTOs), as may be approved by the THASOC to assist for International Juries.

#### 10.4 Board of Jury

The Board of the Jury shall consider and decide on any protests made according to Rule 76 of World Rowing Rules Book (WR) and shall consist of the President of the Jury and two (2) other members of the Jury designated by the President of the Jury on a daily basis prior to the start of each racing day.







#### 11. Official Equipment and Competition Attire

## 11.1 Equipment

- All boats and other equipment must comply with World Rowing Rules of Racing. The blades of all sculls and sweep oars used for competition must be painted on both sides in the colors of their respective Federation in accordance with World Rowing rules. Boats are not allowed to attach any form of commercial advertising without prior agreement with THASOC.
- Oars: Each team is highly recommended to bring their own oars and sculls as the blades of all oars/sculls must be painted on both sides in the colors of the respective Federations.
- Participating Teams encourage to bring their own boats and oars for Rowing Classic.

#### **11.2** Competition Attire

Clothing worn by athletes for competition at the 33rd SEA Games Rowing Competition must comply with the Southeast Asian Games Federation's Charter and Regulation and current World Rowing Rules of Racing.

Participants are not allowed to attach any form of advertising to his or her competition uniform without prior agreement with the THASOC.

#### **Rowing Beach Sprint**

National Team uniforms must comply with the rules of Rowing. Each crew member shall display on their racing uniform the three (3) letter country code and their family name (in Romanized text) in the following manner and format:

#### 12. Media Interview

- 12.1 All athletes should pass through the Mixed Zone as directed by the Media Officer.
- 12.2 Athletes and/or coaches should attend press conference and interview requests for them.

#### 13. Prizes and Commendations

- Medals to the winners of the SEAGF Games shall be presented by the SEAGF
  President. The President may delegate this privilege to other members of the SEAGF,
  accompanied by the President of the IF and/or AF concerned (or their deputy), if
  possible, immediately after the event and where the competition took place in the
  following manner.
- The competitors who have been judged first, second and third shall take their places, in their sports uniforms, on a stand on the field facing the Tribune of Honour, with the winner slightly above the second who is on their right and the third who is on their left.

The flag of the delegates of the winner shall be hoisted on the central flag-pole and those

of the second and third on adjoining flagpoles on the right and on the left, as they face the arena. Meanwhile, the abbreviated National Anthem of the winner is played. The three winners/winning teams shall turn towards the flags.

- The medal presentations shall be as per the following order:
  - Gold Medal to the first-place winner.
  - Silver Medal to the second-place winner.
  - Bronze Medal to the third-place winner.
- All medalists must wear their respective NOC official uniform.
- No equipment or accessories may be taken by the athlete to the medal award ceremony
  or media interview areas, unless it is worn, e.g., shoes and clothing which must be in
  accordance with the SEAGF commercial guidelines.





- No kind of demonstration or commercial, political, religious or racial propaganda is permitted during the Victory Ceremony of the Games. Any action of such kind will be subject to penalization by the Executive Board EB including disqualification, withdrawal of medals, certificates, accreditation, rankings and the like.
- Any disrespect shown to the Games, Medals, Flags, Mascot or Certificates or any other material. by any athlete during the Victory Ceremony or during the Games will be subject to penalization by the EB, including but not limited to disqualification, withdrawal of medals, certificates, accreditation, rankings as decided by the EB.
- Victory, medals and diploma certificates, shall be in strict compliance with the SEAGF Protocol Guidelines. The design and format of the medals and diplomas shall be submitted to the SEAGF for its approval.

#### 14. Victory Ceremonies

The medals may be presented by the board members of the Member-NOCs participating in the particular sport, discipline or event (with priority being given to those with medal winners) and or Guests of Honor of the Federation, and such victory ceremonies, if possible, shall take place immediately after the event at a place where the competition took place and in the following manner:

- The competitors who have been judged first, second and third shall take their places, in their sport attire or NOC designated attire, on a stand facing the Tribune of Honor, with the winner slightly above the second who is on his/her right, and the third who is on his/her left.
- The flag of the country of the winner shall be hoisted on the central flagpole or screen and those of the second and third on adjoining flagpoles or screen on the right and left as they face the arena. Meanwhile, the National Anthem of the country of the winner is played and the competitors and spectators shall face the flags.

#### 15. Medical Code (SEAGF 33)

- The Host NOC and Organizing Committee of the SEA Games will ensure the health of all athletes and other participants during the SEA Games.
- Anti-Doping Rule Violations as defined by the World Anti-Doping Agency (WADA) Code is forbidden.
- All competitors shall be subject, during the Games, to doping control initiated by the Federation at any time or place, carried out in conformity with the WADA Code and its respective International Standards, as elaborated in the SEA Games Anti-Doping Rules.
- Competitors in sports restricted to women must comply with the prescribed tests for disorders of sexual determination when so needed.
- Any competitor refusing to submit to doping control or who is found guilty of any





- Anti-Doping Rule violation shall be excluded from the SEA Games.
- The principles of exclusion for teams and individuals shall be in accordance with the WADA Code.
- A medal may be withdrawn by order of the Executive Committee or the Council on the recommendation of the Chairperson of the Anti-Doping Committee when an athlete is found guilty of a violation under the SEA Games Anti-Doping Rules and or the WADA Code.
- The Anti-Doping Committee shall manage and implement the doping test programme for the SEA Games to which it was appointed for in accordance with WADA requirements, and implement the SEA Games Anti-Doping Rules and WADA Code.
- The SEA Games Anti-Doping Rules and Regulations shall in no way affect further and or other sanctions by the relevant International Federation, WADA and or any other relevant national, regional, continental, international or world organizations or bodies.
- All competitors and officials are also subject to, and shall comply with the
  respective anti-gaming and manipulation, and harassment and abuse, and
  safeguarding rules, regulations, codes and guidelines of the respective Federation
  Member-NOC, IOC, OCA, SEAGF, the respective IF and or AF of the sport
  concerned.
  - a) Any competitor or team official refusing to submit thereto or found guilty of any violation or offence thereunder shall be excluded from the SEA GAMES.
  - b) A medal may be withdrawn by order of the Executive Committee or the Council on the recommendation of the Arbitration Panel when an athlete is found guilty of any violation or offence thereunder."

#### 16. Doping Control

The 33<sup>rd</sup> SEA Games Thailand 2025 Organizing Committee, shall establish the SEAGF Anti-Doping Committee, which shall, under the guidance of the SEAGF and working with the SEAGF Office, be responsible for the Anti-Doping program for the 33<sup>rd</sup> SEA Games Thailand 2025. The Anti-Doping program will be run in accordance with the SEAGF Anti-Doping Rules and the WADA International Standard for Testing and Investigation. Sample analysis will be performed at a WADA-accredited laboratory or as otherwise approved by WADA. Both urine and blood tests will be conducted before and during the competition to ensure compliance.

Athletes requiring the use of a Prohibited Substance or Prohibited Method during the event must apply for a Therapeutic Use Exemption (TUE) through the SEAGF Anti-Doping Committee by the specified deadline (TBC). If an athlete has already been granted a TUE by their National Anti-Doping Organization or International Federation, the SEAGF Anti-Doping Committee will recognize it.





## 17. Approval of the Technical Handbook

This Technical Handbook was approved by The Southeast Asian Rowing Federation (SEARF) on 14 February 2025

Any further amendments to the Technical Handbook shall be circulated via e-mail to the NOCs.
