- 3. For the Dressage (Individual and Team), Jumping (Individual and Team), Eventing (Team), Each NOC may enter a minimum of 3 (three) maximum of four (4) combinations.
- 4. Athletes must be 16 years of age and over (year of birth 2009 or earlier).
- 5. **Horse age eligibility** including: the Eventing must be at least six (6) years, the Dressage must be at least seven (7) years, the Jumping must be at least seven (7) years **(year age in 2025)**.

#### 5. Entries

#### 5.1 Eligibility

- **5.1.1** Only SEAGF member NOCs are entitled to send athletes to participate in the Equestrian Competition of the 33rd SEA Games Thailand 2025
- **5.1.2** Only Nationals of the Country of the NOC shall be qualified to represent the NOC in the Games. All disputes relating to the determination of the Country, which an athlete may represent in the SEA Games shall be resolved in accordance with Article 31 of the South East Asian Games Federation (SEAGF) Charter and Rules as well as Rule 41 and By-law to Rule 41 of the Olympic Charter (Nationality of competitors).
- **5.1.3** Only Nationals of the Country of the NOC shall be qualified to represent the NOC in the Games. All disputes relating to the determination of the Country, which an athlete may represent in the SEA Games shall be resolved in accordance with Article 31 of the South East Asian Games Federation (SEAGF) Charter and Rules as well as Rule 41 and By-law to Rule 41 of the Olympic Charter (Nationality of competitors).
- **5.1.4** The minimum age for athletes in the Equestrian Competition is as follows:
  - For all Eventing, Dressage and Jumping events, competitors must be at least sixteen (16) years of age in 2025, i.e., born in or before 2009.
- **5.1.5** All Athletes competing in the Equestrian events must be registered with the FEI.
- **5.1.6** The minimum age for horses in the Equestrian Competition is as follows:
  - For Eventing (Individual and Team) events, horses must be at least six (6) years of age in 2025.
  - For Dressage (Individual and Team) events, horses must be at least seven (7) years of age in 2025.
  - For Jumping (Team and Individual) events, horses must be at least seven (7) years of age in 2025.
- **5.1.7** All horses competing in the Equestrian events must have a valid and duly completed identification document of the FEI.
- **5.1.8** No reserve horse will be allowed for Dressage events.
- **5.1.9** Each NOC is allowed only one (1) reserve horse per NOC for the Eventing & Jumping events.
- **5.1.10** A horse may be entered and compete in one (1) event only and once entered for an event, any change of event will NOT be permitted.







#### **5.2 Entry Policies**

- **5.2.1** Each NOC may enter a maximum of twenty-two (22) combinations for the Equestrian Competition. (1 combination = 1 athlete and 1 horse)
- **5.2.2** The Eventing event entry policies details are as follows:-
  - Individual: Each NOC may enter a maximum of two (2) combination for the Competition.
  - **Team:** Each NOC may enter a maximum of four (4) combinations for the Competition.
- **5.2.3** The Dressage event entry policies details are as follows:
  - Individual: Each NOC may enter a maximum of four (4) combination for the Competition.
  - **Team:** Each NOC may enter a maximum of four (4) combinations for the Competition
- **5.2.4** The Jumping event entry policies details are as follows:

for Dressage and Jumping events (Years in 2025).

- **Individual:** Each NOC may enter a maximum of four (4) combination for the.
- **Team:** Each NOC may enter a maximum of four (4) combinations for the Competition
- 5.2.5 Athletes must be 16 years of age and over (year of birth 2009 or earlier).5.2.6 Horse must be at least six (6) years for Eventing event and seven (7) years
- \*\*\* NOCs that withdraw their athletes after the submission of the final entries by name, will be faced with disciplinary action by the SEAGF Charter and Rules.

#### 8. General Rules and Regulations

#### 8.1 Rules

#### 8.1.1 Eligibility Code (SEAGF 30)

To be eligible for participation in the SEA Games, a competitor must comply with the Federation's rules, regulations and by-laws, including this Charter and Rules, in relation to eligibility and Nationality, as well as the related provisions in the Olympic Charter, and the rules, regulations and by-laws for participation in the Olympic Games."

#### 8.1.2 Nationality of Competitor (SEAGF 31)

Only Nationals of the Country of the NOC who are holding current valid National passports of the county of that Member-NOC shall be qualified and eligible to represent the Member-NOC in the SEA Games. All disputes relating to the determination of the Country which a competitor may represent in the SEA Games shall be decided by the Arbitration Panel established under this Charter and Rules, in accordance with the Federation's rules, regulations and by-laws, including this Charter and Rules, relating to eligibility and Nationality."

#### **8.1.3** Number of Entries (SEAGF 34.3, 37)

- a) A minimum of four (4) NOCs must register to participate by the respective closing date of both the Entry by Number and the Entry by Name registration in a sport or discipline or team event and in the case of an individual event, a minimum of three (3) NOCs must register to participate by the closing date of both the Entry by Number and Entry by Name registration, for it to be included in the SEA Games programme. For the avoidance of doubt:
  - A doubles event shall be considered an individual event.
  - There shall be no waiver of this Rule on minimum entry."
- b) The maximum number of entries from each Nation in each event is fixed by the Federation in consultation with the Host NOC. However, the following numbers cannot be exceeded:
  - For individual events, including singles and doubles events, there shall only be two (2) entries from each NOC (without reserves) EXCEPT for the sports with weight category, such as all martial arts and combat sports, Body-building, Weightlifting, etc., where there shall only be one (1) entry per weight category or per event from each NOC; and for the sport of Sailing, where there shall only be one (1) entry per event from each NOC.
  - For team events, there shall be one (1) team per NOC, and the number





- of reserves shall not exceed the number of players allowed by the International Federation.
- For all events where individual Competitions are conducted, the competitors for any one (1) NOC cannot win more than two (2) medals in the respective individual events.
- No Federation Member-NOC, including the Host NOC or the Organizing Committee of any SEA Games, is allowed to limit the participation of any other Federation Member-NOC or any athlete from participating in any sport, discipline or event solely on the ground or

for any reason of limitation of participation."

#### 8.1.7 Technical Officials and Jury of Appeal (SEAGF 41)

- a) The necessary technical officials, referees, judges, umpires, timekeepers, inspectors and other technical officials (collectively "International Technical Officials" or ITOs") and a Jury of Appeal for each sport in such number as shall be determined by the Host NOC or the Organizing Committee, shall be appointed by the Host NOC or Organizing Committee in consultation with the appropriate IF/AF and in cooperation with the respective National Federation of the Host NOC or local sport official/representative. All such ITOs and Jury of Appeal officials approved and appointed by the Host NOC or Organizing Committee shall be referred collectively as "IF/AF International Technical Officials" or IF/AF ITOs" and "Jury of Appeal" accordingly.
- b) The Organizing Committee shall pay for the air or International travel (based on best economy fare to the host city), accommodation (equivalent to a hotel of at least a 3-star Internationally accepted rating, based on twin-share basis except for single rooms for Technical Delegates, Chief Umpires and Chief Scorer), meals, official local transport expenses and a per diem only of the IF/AF ITOs and Jury of Appeal officials at the established rates of the Organizing Committee starting from within than two (2) days before the start of the first event of the sport or discipline concerned until one (1) day after the end of the





- Competition of the last event of that sport or discipline.
- In approving and appointments of ITOs and Jury of Appeal members, all IF and or AF concerned must give priority, first to the appointment of qualified ITOs and Jury of Appeal members who reside within the South East Asian (SEA) region, and second, to those who reside within the Asian continent, before appointing any ITOs or Jury of Appeal members from outside the SEA region or Asia continent.
- d) No official who has participated in a decision may serve in the Jury of Appeal that reviews it. The findings of the Jury of Appeal shall be communicated as soon as possible to the Federation Office, Host NOC, Organizing Committee and Executive Committee.
- e) Technical officials and members of the Jury of Appeal may not live in the Games Villages, but the Organizing Committee shall ensure and bear the cost of their accommodation, including board and local transport facilities at such established rates of the Organizing Committee.
- f) The Jury of Appeal's decision(s) on all technical questions concerning its respective sport or of disciplinary nature is/are final. Such decision shall, however, be without prejudice to any further penalty and or sanction, which may be imposed by the Executive Committee.
- g) The Jury of Appeal shall be composed of a Chairperson (who shall be the Technical Delegate) and not more than two (2) other representatives as Jury of Appeal members, who shall be appointed by the IF/AF from amongst the IF/AF ITOS and or IF/AF representative(s) present at the Games.
- h) In the event of a dispute or protest relating to technical questions concerning its respective sport, discipline and or event, or Competition or any matter that is disciplinary in nature, that is referred to a relevant Jury of Appeal, representatives of Countries in the Jury of Appeal whose Countries are involved in the dispute or protest must NOT participate in the deliberations and or decision making and cannot vote in the resolution of the dispute or protest.
- i) Any NOC dissatisfied with any decision of any Jury of Appeal (except decisions concerning matters of fact and judgment calls where no appeal is allowed) may refer his/her appeal to the Panel of Arbitrators

#### 8.1.8 Arbitration Panel (SEAGF 42)

The Arbitration Panel shall deliberate and decide finally on all questions concerning the SEA Games or protests or appeals (including on any violation of anti-doping code, rules or regulations) from any sport, discipline or event or any disputes arising from or related to the SEA Games. NOCs or the Organizing Committee may also submit questions or any matter related to the





SEA Games to the Arbitration Panel for determination. Further, the Arbitration Panel may intervene in and determine all questions of non-technical nature outside the jurisdiction of the Jury of Appeal set up for each sport, discipline or event in the Games program.

#### 8.1.9 Penalty in case of Fraud (SEAGF 44)

A competitor proved to have fraudulently transgressed or breached any provisions of the Charter, Rules, Regulations or By-laws of the Federation shall be disqualified and lose any position or medal he/she may have gained. If this competitor's NOC is proved to have been a party to the fraud, his/her Country shall be disqualified in the sport concerned.

#### 9. Competition and Training Rules and Regulations

#### 9.1 Competition Rules

The Equestrian Competition of the 33rd SEA Games Chonburi 2025 will be held in accordance with the current Fédération Équestre Internationale (FEI) Rules and Regulations under the guidance of the Technical Delegate (TD) appointed by FEI.

In case of any disagreement in the language interpretation of the FEI Rules and Regulations, the English version shall prevail. Any unforeseen cases not covered by the Rules and Regulations shall be resolved as follows:

- **9.1.1 General Issues:** To be resolved in accordance with the SEAGF Charter and Rules.
- **9.1.2 Technical Issues:** To be resolved in accordance with FEI Rules and Regulations and FEI Norms.

#### The FEI Rules and Regulations applicable include, without limitation:

- FEI Statutes, 25th edition, update effective 21 November 2023
- FEI General Regulation, 24th Edition, updates effective 01 January 2025
- FEI Veterinary Regulations, 15th edition 2023, update effective 1 January 2025
- FEI Eventing Rules, 26th Edition effective 1st January 2023, updates effective 1st January 2025
- FEI Dressage Rules 26th Edition, updates effective 01 January 2025
- FEI Jumping Rules, 27th Edition, updates effective 1 January 2025
- FEI Equine Anti-Doping and Controlled Medication Regulations (EADCMR), 4th Edition, effective 01 January 2025
- WADA Code, effective 1 January 2021.







#### 9.2 Competitional Format

#### 9.2.1 Eventing Events

The Individual and Team consist of 1 Competition organized over ONE day based on a FEI Eventing World Challenge Category A format.

• 1x Dressage Test + 1x Jumping Course followed by a Cross Country Course

#### The size of the arena

Dressage: 60 x 20 meters.Jumping: 65 x 45 meters

• Cross Country: Length 1800 meters

1) Dressage: Category A Dressage test (CCI1\* Dressage test A)

2) Show Jumping course with up to 12 fences (max. 14 efforts) of 1.00m high – maximum 450 m long - speed 350 m/min.

3) Cross Country course with 12x fences (max. 14 efforts) of 95cm-1.00m

high with one water jump - 1800 m long @ 450 m/min.

#### **Dressage Team Competitions:**

The Team Classification is decided on the test of **FEI Juniors Individual** Competition as follows: the winning team is the one having the highest total scores of their three (3) best Athletes, the second placed team is the one with the next highest score and so on.

Ties. In case of equality of scores, the higher ranked team will be the one whose lowest classified athlete out of the three (3) has the best result.







#### **Dressage Individual Competitions**

Individual Competition consists of three Competitions.

- The **FEI Juniors Individual** Competition (1<sup>st</sup> individual qualifier) is open to all Athlete/Horse combinations entered.
- Each participating NOC may enter a maximum of four (4) athletes.
- The **FEI Prix St. Georges** (2<sup>nd</sup> individual qualifier) is open to all Athlete/Horse combinations who previously completed the **FEI** Juniors Individual.
- The **FEI Young Riders Freestyle** (individual final) is open and compulsory for the best 15 Athlete/Horse combinations from the **FEI Prix St. Georges**, with a maximum of two (2) Athletes per NOC.

There will be no adding of percentages from the team Competition and Individual Competitions, but all Competitions start from zero (0) i.e. all Athletes will start each Competition with zero (0) points.

In all Competitions the winner is the Athlete having obtained the highest total percentage, the second placed Athlete is the one with the next highest total and so on. Ties in the **FEI Young Riders Freestyle**: In case of equality of percentage in a Freestyle Test for the first three (3) places, the higher artistic marks will decide on the better placing. Should the artistic mark be the same, the higher mark for harmony will decide. If still tied the higher mark for choreography will decide. In case of equality of percentage for remaining places, the Athletes are given the same placing.

#### 9.2.3 Jumping Events

The Jumping Individual and Team Events formats shall be as follows:

• Competition Arena: Outdoor Fiber Sand arena

• **Dimension of arena:** 55m x 90m

#### 9.2.3.1 Jumping Team Competition:

Height: 120 cm Speed: 350m/min

#### 9.2.3.2 Jumping Individual Competitions:

(Article 238.1.1; 238.2.2), FEI Jumping Rules, 27th edition, effective

1 January 2022, updates effective 1st January 2025

Height: 130 cm Speed: 350m/min







#### **Jumping Team Event**

- (i) Each NOC may enter a minimum of three (3) combinations (athletes and horses) and a maximum of four (4) combinations for the Jumping Team Event
- (ii) An NOC with less than three (3) combinations must compete in the Team Competition to obtain qualifying scores for the First Individual Competition.
- (iii) The Jumping Team Competition will comprise of two (2) rounds, both rounds not against the clock. All teams, if not eliminated or retired, return for Round 2.
- (iv) If two or more athletes of a Team with four athletes or if one or more athletes of a Team with three athletes are eliminated or retire or are disqualified in Round 1 of the Team Competition, the whole Team is eliminated and is not allowed to return as a Team in Round 2. In this case only the athletes of the Team(s) in question who completed Round 1 may continue to Round 2 to complete their individual qualification.
- (v) The starting order in Round 1 of the Team Competition will be drawn. A draw will first take place to decide the order of starting of the individual athletes entered in addition to the Teams. A second draw will then take place to decide the order in which the Teams will start. Each Chef d'Equipe will then fix the order in which they wish their Team athletes to start. These athletes will be inserted in sequence in the remaining spaces between the individual athletes.
  - The starting order of Round 2 of the Team Competition will be based on the reverse order of the total penalties of the best three (3) athletes of each team in Round 1. Teams with equality of penalties retain the same starting order as in Round 1.
- (vi) Classification will be decided by adding the total penalties incurred by the best three (3) combinations from each team in two (2) rounds of the Team Competition.
- (vii) The top three (3) teams with the lowest total number of penalties from both rounds will be placed 1st, 2nd and 3rd.

#### **Jumping Individual Event**

- (i) All Participants shall qualify for the First Individual Competition but must have taken part in both rounds of the Team Competition without having been eliminated or having retired.
- (ii) Four (4) combinations per NOC may take part in the First Individual Competition.





- (iii) The Jumping Individual Event will comprise of two (2) Competitions: First Individual Competition one round not against the clock (FEI Jumping Rules Art. 238.1.1)

  Individual Final Competition one round against the clock with Jump-off (FEI Jumping Rules Art. 238.2.2)
- (iv) The starting order for both Competitions will be drawn.
- (v) Only the two (2) best combinations from each NOC in the First Individual Competition may start in the Individual Final Competition, based on penalties in the First Individual Competition.
- (vi) In case of equality of penalties among two (2) combinations from the same NOC, the Chef d'Equipe shall decide which of the two (2) combinations should continue to the Individual Final Competition.
- (vii) Athletes who have been eliminated or who have retired in the First Individual Competition, may not take part in the Individual Final Competition.

#### **Tie-Break Procedures**

#### **Jumping Team Event**

- (i) In the event of a tie in total penalties for 1st, 2nd and/or 3rd places, a jump-off against the clock is compulsory in which all the Team members must compete. The jump-off for 3rd place shall take place before the jump-off for the 1st and 2nd place.
- (ii) The tie shall be broken in the following manner:
  - The Team (best three (3) results) with the lowest total number of penalties incurred during the jump-off shall be declared the winner.
  - If there is still a tie, the Team (best three (3) results) with the fastest time during the jump-off shall be declared the winner.
  - If there is still a tie, tied teams are placed equal.
- (iii) Teams with equality of total penalties for other places are placed equal.







#### **Jumping Individual Event**

- (i) In the event of a tie in penalties for 1st, 2nd and/or 3rd places following the initial round of the Individual Final Competition, a jump-off against the clock is compulsory. The jump-off for 3rd place shall take place before the jump-off for the 1st and 2nd place. The tie shall be broken in the following manner:
  - In case of equality of penalties and time for any of the medal placing after the 1st jump-off, a 2nd jump-off will be held over the same course.
  - If there is still a tie, the combinations concerned will be placed equal.
  - Other combinations not taking part in the jump-off are placed according to their penalties and time in the initial round of the Individual Final Competition.
  - Combinations equal in penalties and time are placed equal.
  - The order of starting in the possible jump-off for medal placing will be the same as in the initial round of the Individual Final Competition.

#### 9.3 Training Policies

Pre-Competition training will be allocated to all NOCs two (2) days prior to the start of the Competition for the sports (including familiarisation, if necessary). Training sessions are strictly by allocation; no change and addition of training requests are allowed. NOCs are required to notify the Sport Information Desk if any NOC does not intend to use the allocated training session

#### 9.4 Equipment at Training Venues


Training venues for Dressage and Jumping will be equipped with Dressage boundaries and jumping sets.

#### 9.6 Protests and Appeals

All Protests will be dealt with in accordance to the FEI Rules, Protests: Article 161 - Protests.

All Protests must be filed within the appropriate time frame, and by the appropriate parties (Article 161.3 & 161.4), with the exception of Article 161.5 (Protests concerning an abuse of Horse may be lodged by any person or body). All Protests must be in writing, signed and submitted with a deposit of CHF 150.00.- (One hundred and fifty CHF or the equivalent in the local currency) with the exception of any protests regarding Horse Abuse of any nature (Article 142). The deposit will be refunded if the protest is successful. If the protest is dismissed the deposit will not be refunded.

All Appeals will be dealt with in accordance to the FEI Rules, Appeals: Article 162 - Appeals.

All Protests must be filed within the appropriate time frame, Appeals against a decision of the Ground Jury arising from a Protest must be made in writing, signed and accompanied by supporting evidence in writing or by one or more witnesses and





must be submitted to the FEI Tribunal no later than fourteen (14) days after the end of the Event, with a deposit of CHF 500.00,- (Five hundred CHF) in order to be eligible. The Appeals Proceedings will be done in accordance to FEI Rules, Article 162 - Appeals.

#### 9.7 Delays, Postponement or Cancellations

The Technical Delegate must consult the THASOC Secretariate if there is any delay, postponement or cancellation of any Competition that affects the scheduled times for "live broadcast" or victory ceremonies.

#### 10. Technical Officials and Jury of Appeal

The appointment of Technical Officials and Jury of Appeal will comply with the Fédération Équestre Internationale (FEI) Rules and Regulation, in accordance with Article 41 of the SEAGF Charter and Rules.

#### 10.1 International Technical Officials (ITOs)

The THASOC DIRECTOR/ASSISTANT DIRECTOR OF SPORTS is responsible to request the official appointment of the ITOs from the Fédération Équestre Internationale (FEI)

#### 10.2 National Technical Officials (NTOs)

The THASOC DIRECTOR/ASSISTANT DIRECTOR OF SPORTS is responsible to request the official appointment of the NTOs from The Thailand Equestrian Federation

#### 10.3 Jury of Appeal

The Jury of Appeal shall comprise of the members of the event Technical Committee. The Technical Delegate will act as its chairman. The decision of the Jury of Appeal shall be final.

#### 11. Official Equipment and Competition Attire

#### 11.1 Sports Equipment

All sports equipment used by athletes in Competition must comply with the SEAGF Charter and Rules and FEI Rules and Regulations.

#### 11.2 Competition Attire

All clothing worn by athletes in Competition must comply with the SEAGF Charter and FEI Rules and Regulations.

#### 12. Media Interview

- **12.1** All athletes should pass through the Mixed Zone as directed by the Media Officer.
- **12.2** Athletes and/or coaches should attend press conference and interview requests for them.

- Medals to the winners of the SEAGF Games shall be presented by the SEAGF
  President. The President may delegate this privilege to other members of the SEAGF,
  accompanied by the President of the IF and/or AF concerned (or their deputy), if
  possible, immediately after the event and where the Competition took place in the
  following manner.
- The competitors who have been judged first, second and third shall take their places, in their sports uniforms, on a stand on the field facing the Tribune of Honour, with the winner slightly above the second who is on their right and the third who is on their left. The flag of the delegates of the winner shall be hoisted on the central flag-pole and those
  - of the second and third on adjoining flagpoles on the right and on the left, as they face the arena. Meanwhile, the abbreviated National Anthem of the winner is played. The three winners/winning teams shall turn towards the flags.
- The medal presentations shall be as per the following order:
  - Gold Medal to the first-place winner.
  - **Silver Medal** to the second-place winner.
  - **Bronze Medal** to the third-place winner.
- All medalists must wear their respective NOC official uniform.
- No equipment or accessories may be taken by the athlete to the medal award ceremony or media interview areas, unless it is worn, e.g., shoes and clothing which must be in accordance with the SEAGF commercial guidelines.
- No kind of demonstration or commercial, political, religious or racial propaganda is
  permitted during the Victory Ceremony of the Games. Any action of such kind will be
  subject to penalization by the Executive Board EB including disqualification,
  withdrawal of medals, certificates, accreditation, rankings and the like.





- Any disrespect shown to the Games, Medals, Flags, Mascot or Certificates or any other
  material. by any athlete during the Victory Ceremony or during the Games will be
  subject to penalization by the EB, including but not limited to disqualification,
  withdrawal of medals, certificates, accreditation, rankings as decided by the EB.
- Victory, medals and diploma certificates, shall be in strict compliance with the SEAGF Protocol Guidelines. The design and format of the medals and diplomas shall be submitted to the SEAGF for its approval.

#### 14. Victory Ceremonies

The medals may be presented by the board members of the Member-NOCs participating in the particular sport, discipline or event (with priority being given to those with medal winners) and or Guests of Honor of the Federation, and such victory ceremonies, if possible, shall take place immediately after the event at a place where the Competition took place and in the following manner:

- The competitors who have been judged first, second and third shall take their places, in their sport attire or NOC designated attire, on a stand facing the Tribune of Honor, with the winner slightly above the second who is on his/her right, and the third who is on his/her left.
- The flag of the Country of the winner shall be hoisted on the central flagpole or screen and those of the second and third on adjoining flagpoles or screen on the right and left as they face the arena. Meanwhile, the National Anthem of the Country of the winner is played and the competitors and spectators shall face the flags.

#### 15. Medical Code (SEAGF 33)

- The Host NOC and Organizing Committee of the SEA Games will ensure the health of all athletes and other participants during the SEA Games.
- Anti-Doping Rule Violations as defined by the World Anti-Doping Agency (WADA) Code is forbidden.
- All competitors shall be subject, during the Games, to doping control initiated by the Federation at any time or place, carried out in conformity with the WADA Code and its respective International Standards, as elaborated in the SEA Games Anti-Doping Rules.
- Competitors in sports restricted to women must comply with the prescribed tests for disorders of sexual determination when so needed.
- Any competitor refusing to submit to doping control or who is found guilty of any Anti-Doping Rule violation shall be excluded from the SEA Games.
- The principles of exclusion for teams and individuals shall be in accordance with the WADA Code.
- A medal may be withdrawn by order of the Executive Committee or the Council on the recommendation of the Chairperson of the Anti-Doping Committee when an





- athlete is found guilty of a violation under the SEA Games Anti-Doping Rules and or the WADA Code.
- The Anti-Doping Committee shall manage and implement the doping test programme for the SEA Games to which it was appointed for in accordance with WADA requirements, and implement the SEA Games Anti-Doping Rules and WADA Code.
- The SEA Games Anti-Doping Rules and Regulations shall in no way affect further and or other sanctions by the relevant International Federation, WADA and or any other relevant National, Regional, Continental, International or World Organizations or Bodies.
- All competitors and officials are also subject to, and shall comply with the respective anti-gaming and manipulation, and harassment and abuse, and safeguarding rules, regulations, codes and guidelines of the respective Federation Member-NOC, IOC, OCA, SEAGF, the respective IF and or AF of the sport concerned.
  - a) Any competitor or team official refusing to submit thereto or found guilty of any violation or offence thereunder shall be excluded from the SEA GAMES.
  - b) A medal may be withdrawn by order of the Executive Committee or the Council on the recommendation of the Arbitration Panel when an athlete is found guilty of any violation or offence thereunder."

#### 16. Doping Control (Human)

The 33<sup>rd</sup> SEA Games Thailand 2025 Organizing Committee, shall establish the SEAGF Anti-Doping Committee, which shall, under the guidance of the SEAGF and working with the SEAGF Office, be responsible for the Anti-Doping program for the 33<sup>rd</sup> SEA Games Thailand 2025. The Anti-Doping program will be run in accordance with the SEAGF Anti-Doping Rules and the WADA International Standard for Testing and Investigation. Sample analysis will be performed at a WADA-accredited laboratory or as otherwise approved by WADA. Both urine and blood tests will be conducted before and during the Competition to ensure compliance.

Athletes requiring the use of a Prohibited Substance or Prohibited Method during the event must apply for a Therapeutic Use Exemption (TUE) through the SEAGF Anti-Doping Committee by the specified deadline (TBC). If an athlete has already been granted a TUE by their National Anti-Doping Organization or International Federation, the SEAGF Anti-Doping Committee will recognize it.

#### **Equine Athletes**

Fédération Équestre Internationale (FEI) has the exclusive right to carry out testing for Equine Anti-Doping and Controlled Medications. The anti-doping work will be conducted in accordance with the FEI EADCM Rules and administered by the FEI Veterinary Department. Testing Personnel will be appointed and renumerated by the FEI in liaison with the Organising Committee.





#### 17. Sport Information Desk

All sports specific information will be available at the Sport Information Desk located at the Competition venue and at the official hotels

#### 18. Veterinary Requirements

- The 2025 FEI Veterinary Regulations provides the regulatory framework for the veterinary requirements related to the Games.

- Quarantine and temporary movement of horses: Import and re-export requirements such as quarantine regulations and vaccination will be enforced as required by the host Country.






